A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AWARDING INVITATION FOR BIDS IFB-192-24-WV FOR CITY OF HOLLYWOOD BEVERLY PARK VARIOUS LOCATIONS - SIDEWALK TO HOMESTEAD CONCRETE DRAINAGE, INC.; & APPROVING AND AUTHORIZING THE APPROPRIATE CITY TO EXECUTE Α CONTRACT HOMESTEAD CONCRETE & DRAINAGE, INC. FOR CONSTRUCTION OF THE BEVERLY PARK SIDEWALK AND ADA COMPLIANCE PROJECT IN AN AMOUNT UP TO \$2,511,030.00; AMENDING THE FISCAL YEAR 2024 OPERATING BUDGET AND CAPITAL IMPROVEMENT PLAN.

WHEREAS, on November 1, 2017, the City Commission passed and adopted Resolution No. R-2017-323, authorizing appropriate City officials to submit the Complete Streets and other Localized Initiatives Program ("CSLIP") funding application for the Beverly Park Sidewalks and ADA Compliance Project, and the Hollywood Beach Heights and Hollywood Country Estates Sidewalk, ADA Compliance, and North 58th Avenue Sharrow Installation Project (collectively referred to as "CSLIP Projects"); and

WHEREAS, on April 20, 2022, the City Commission passed and adopted Resolution No. R-2022-104, approving and authorizing the appropriate City officials to execute Local Agency Program ("LAP") Agreements in order to receive reimbursement funds for the design of the Beverly Park Sidewalk Project; and

WHEREAS, on December 7, 2022, the City Commission passed and adopted Resolution No. R-2022-353, approving and authorizing appropriate City officials to execute a Professional Services Agreement with Kimley Horn and Associates, Inc. for the design and permitting of the Beverly Park Sidewalks Project in an amount up to \$531,541.00; and

WHEREAS, on January 17, 2024, the City Commission passed and adopted Resolution No. R-2024-006, approving and authorizing the appropriate City officials to accept and execute Beverly Park Sidewalks LAP Agreements for construction and construction engineering inspection, including federal funding in the amounts of \$2,365,253.00 and \$331,978.00, respectively; and

WHEREAS, on April 3, 2024, the City advertised on www.Opengov.com Invitation for Bids IFB-192-24 WV for 443944-1-58 City of Hollywood Park Various Locations - Sidewalk ("IFB-192-24-WV"), or, more specifically, for construction services for Beverly Park Sidewalk Network; and

WHEREAS, on May 6, 2024, the Department of Procurement and Contract Compliance and the Department of Design and Construction Management ("DCM") received bids as listed below:

WHEREAS, DCM and the Department of Procurement and Contract Compliance reviewed and evaluated the submitted bids in accordance with Section 38.43(F) of the City's Procurement Code and, after the evaluation, Homestead Concrete & Drainage, Inc. was determined to be the best value and the lowest responsive and responsible bid; and

WHEREAS, on June 6, 2024, a Notice of Intent of Award was posted on the City's website and on www.Opengov.com, and resulted in no bid protests; and

WHEREAS, the Director of DCM and the interim Chief Procurement Officer recommend that the City Commission award IFB-192-24-WV to Homestead Concrete & Drainage, Inc. and approve and authorize the appropriate City officials to execute a contract with Homestead Concrete & Drainage, Inc. in the amount of \$2,511,030.00; and

WHEREAS, the Fiscal Year 2024 (FY 2024) Operating Budget was adopted and approved by the City Commission pursuant to Resolution R-2023-300 at the second Public Budget Hearing on September 20, 2023; and

WHEREAS, the FY 2024 Capital Improvement Plan was adopted and approved by the City Commission pursuant to Resolution R-2023-301 at the second Public Budget Hearing on September 20, 2023; and

- WHEREAS, it is necessary to amend the approved FY 2024 Operating Budget and Capital Improvement Plan as set forth in the attached Exhibit "1".
- NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
- <u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
- <u>Section 2</u>: That it awards the IFB-192-24-WV to the lowest responsive, responsible bidder, Homestead Concrete & Drainage, Inc.
- <u>Section 3</u>: That it approves and authorizes the execution, by the appropriate City officials, of a contract with Homestead Concrete & Drainage, Inc. for the construction of the Beverly Park Sidewalks and ADA Compliance Project, in a form acceptable to the City Manager and approved as to form by the City Attorney.
- Section 4: That these Amendments to the FY 2024 Operating Budget and FY 2024 Capital Improvement Plan for the Fiscal Year beginning October 1, 2023 and set forth in detail in the attached Exhibit "1" are adopted and authorized as Amendments and/or Adjustments to the Operating Budget and Capital Improvement Plan of the City of Hollywood, Florida, for the Fiscal Year 2024.
- <u>Section 5</u>: That the Department of Financial Services is authorized to establish such line-item accounts as may be necessary to properly monitor and track appropriations.
- <u>Section 6</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
