

RESOLUTION NO. R-CRA-2023-

A RESOLUTION OF THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY (“CRA”), CHANGING THE REGULAR CRA BOARD MEETINGS IN OCTOBER 2024 AND JANUARY 2025.

WHEREAS, pursuant to a series of resolutions, the Community Redevelopment Agency (“CRA”) Board has adopted its regular meeting schedule as the first Wednesday of each month starting at 9:00 A.M, except during the month of August; and

WHEREAS, the CRA Board desires to change the regularly scheduled Wednesday, October 2, 2024 meeting to Tuesday, October 1, 2024, with citizens’ comments at 9:00 A.M., due to Rosh Hashanah; and

WHEREAS, the CRA Board desires to change the regularly scheduled Wednesday, January 1, 2024 meeting to Wednesday, January 15, 2025, with citizens’ comments at 9:00 A.M, due to the holidays.

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

Section 1: That the foregoing “WHEREAS” clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That the regular meeting of the CRA Board scheduled on Wednesday, October 2, 2024 is rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Tuesday October 1, 2024, with citizens’ comments at 9:00 A.M.

Section 3: That the regular meeting of the CRA Board scheduled on Wednesday, January 1, 2025 shall be rescheduled in the City Commission Chambers at City Hall, 2600 Hollywood Boulevard, to Wednesday, January 15, 2025, with citizens’ comments at 9:00 A.M.

Section 4: Thereafter, regular meetings of the CRA Board shall, unless otherwise provided by Resolution, be held on the first Wednesday of each month.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
