A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO APPLY FOR AND IF AWARDED, ACCEPT FUNDING FROM THE BROWARD COUNTY CYCLE I TRANSPORTATION SURTAX FUND TO IMPLEMENT REHABILITATION AND MAINTENANCE PROJECTS; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL APPLICABLE PROGRAM DOCUMENTS ASSOCIATED WITH THE BROWARD COUNTY CYCLE I TRANSPORTATION SURTAX FUND APPLICATIONS.

WHEREAS, on September 20, 2018, the City Commission passed and adopted Resolution No. R-2018-287, authorizing the appropriate City officials to execute the Transportation System Surtax Interlocal Agreement with Broward County and the Broward County Metropolitan Planning Organization, setting forth conditions for municipal project funding and supporting the 2018 transportation surtax ballot measure; and

WHEREAS, on November 6, 2018, the voters of Broward County approved the Transportation Surtax ballot measure; and

WHEREAS, on June 11, 2019, the Broward County Board of Commissioners approved the First Amendment to the Transportation Surtax Agreement; and

WHEREAS, on April 1, 2020, Broward County finalized Cycle I evaluation criteria and opened an application portal for municipal rehabilitation and maintenance projects; and

WHEREAS, the Department of Development Services, Engineering, Transportation and Mobility Division has identified the following rehabilitation and maintenance projects that improve City streets, congestion, sidewalks, and neighborhood flooding:

- Milling and resurfacing, sidewalk repairs, additional ADA access points on cross-streets, and drainage improvements located on Liberty Street between North Park Road and North 31st Street;
- (2) Milling and resurfacing, sidewalk repairs, additional ADA access points on cross-streets, and the extension of an existing drainage swale located on North 58th Avenue between Johnson Street and Sheridan Street;

- (3) Milling and resurfacing, sidewalk repairs, additional ADA access points on cross-streets, additional cross walks, modifications to left turn lanes to reduce congestion and improve safety, located on North Park Road between Sheridan Street and Oak Drive; and
- (4) Milling and resurfacing, sidewalk repairs, and additional ADA access points on cross-streets at the following areas:
 - a. Raleigh Street between North Park Road and North 38th Avenue
 - b. Sarazen Drive between North 35th Street and North 46th Avenue
 - c. North 26th Avenue between Taft Street and Sheridan Street
 - d. West Park Road between North Park Road and North 40th Avenue

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing 'WHEREAS' clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the appropriate City officials to apply for Broward County Cycle I Transportation Surtax Funding to implement the aforementioned rehabilitation and maintenance projects.

<u>Section 3</u>: That the City Manager is authorized to accept such funding, if awarded, provided that the City Manager has the discretion to refuse the funding in those circumstances where he determines it is in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the funding.

Section 4: That upon funding from The Broward County Transportation Surtax Fund being awarded to the City, and the City Manager accepting the award, the appropriate City officials are authorized to execute all agreements and applicable documents in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.
