A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED REPLAY ACCESS AGREEMENT FOR MUNICIPALITIES BETWEEN THE CITY OF HOLLYWOOD AND BROWARD COUNTY FOR THE USE AND ACCESS OF THE REPLAY SOFTWARE SYSTEM RELATING TO E911.

WHEREAS, on June 17, 2013, Broward County and Replay Systems, Inc. entered inter an Assignment, Delegation, and Release Agreement which assigned the Maintenance Agreement and Digital Voice Agreement from the Broward Sheriff's Office ("BSO") to the County relating to the E911 System; and

WHEREAS, as part of the Replay Agreements, BSO and various municipalities of Broward county, including those that host public answering points, utilize the software licensed under the Replay Agreement and under the Replay PSAP Agreement, these municipalities receive the benefit of Replay's services and purchase additional equipment or software from Replay; and

WHEREAS, the Replay Agreements granted a server software license to the County for use and access to the Replay software that provides recording functionalities on the E911 voice recording system, which is utilized by the public safety answering points in Broward County; and

WHEREAS, the attached Replay Access Agreement allows the City's Police Department to use and access the licensed software (voice recording system) solely for internal governmental purposes pursuant to the terms and conditions set forth in the Agreement; and

WHEREAS, the attached Replay Access Agreement requires the City to indemnify and hold harmless Broward County; and

WHEREAS, the Chief of Police for the City of Hollywood recommends that the City Commission authorize the appropriate City Officials to execute the attached Replay Access Agreement between Broward County and the City of Hollywood;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
