

RESOLUTION NO. R-CRA-2021 \_\_\_\_\_

A RESOLUTION OF THE HOLLYWOOD, FLORIDA, COMMUNITY REDEVELOPMENT AGENCY (“CRA”), APPROVING FUNDING TO CIRCUIT TRANSIT INC., FORMERLY KNOWN AS THE FREE RIDE, FOR CIRCULATOR SERVICES IN AN ESTIMATED ANNUAL AMOUNT OF \$590,240.00.

WHEREAS, on October 17, 2018, the City Commission passed and adopted Resolution No. R-2018-335 authorizing the execution of an agreement with Free Ride, now known as Circuit Transit Inc., for circulator services to and from Downtown Hollywood, Hollywood Beach, and the City’s parking garages; and

WHEREAS, the initial term of the agreement was for one year with the option to renew for three additional one year periods upon mutual agreement of the parties; and

WHEREAS, on September 4, 2019, the Community Redevelopment Agency (“CRA”) passed and adopted Resolution No. R-CRA-2019-38 authorizing two thirds of the cost for circulator services to be paid by the CRA, with the City paying the remaining one third of the cost; and

WHEREAS, on May 20, 2020, the City Commission passed and adopted Resolution No. R-2020-105, authorizing the first renewal of the agreement for a one year period; and

WHEREAS, on May 20, 2020, the CRA Board passed and adopted Resolution No. R-CRA-2020-18, authorizing two thirds of the cost for circulator services to be paid by the CRA for the first renewal period; and

WHEREAS, the current agreement expired on March 3, 2021, and the parties desire to renew the existing agreement under the same terms and conditions for an additional one year period, which will commence retroactively on March 5, 2021 and will expire on March 4, 2022; and

WHEREAS, the total estimated annual cost of circulator services is \$885,360.00; and

WHEREAS, funding for this project will continue to be shared jointly by the CRA and the City; and

WHEREAS, funding for the CRA's portion of this expenditure (\$590,240.00) is available in account numbers 163.638504.55200.548060.000000.000.000 and 166.668602.55200.548060.000000.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the funding for the CRA's portion of the circulator services in the amount of \$590,240.00 to Circuit Transit Inc.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
