

RESOLUTION NO. 2025/120

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DEERFIELD BEACH, FLORIDA, APPROVING THE AWARD OF ITB #25-016 FOR THE SUPPLY AND DELIVERY OF SULFURIC ACID 93% ON AN AS NEEDED BASIS FOR THE WATER TREATMENT PLANT TO SHRIEVE CHEMICAL COMPANY, LLC, AS THE PRIMARY VENDOR, AND INTERACID NORTH AMERICA, INC. AS THE SECONDARY VENDOR, IN A TOTAL AGGREGATE ANNUAL AMOUNT NOT TO EXCEED \$226,660.00; AUTHORIZING EXECUTION OF CONTRACTS WITH THE TWO RESPONSIVE AND RESPONSIBLE BIDDERS FOR A THREE-YEAR TERM WITH THREE ADDITIONAL ONE-YEAR RENEWAL OPTIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City, as lead agency for the Southeast Florida Governmental Purchasing Cooperative Group, issued Invitation to Bid #25-016 (the “ITB”) seeking qualified vendors for the supply and delivery of Sulfuric Acid 93% (the “Chemicals”) for the City’s water treatment plant operations and for use by the Group’s participating members; and

WHEREAS, the ITB was advertised in the legal notices section of Broward County’s designated public website on April 18, 2025, and the notice was sent to 54 prospective vendors via the e-Procurement Marketplace with 11 vendors viewing the ITB documents; and

WHEREAS, on May 14, 2025, at 2:00 p.m., the ITB due date and time, the Purchasing and Contract Division (the “Division”) opened the two (2) bid responses that were timely received, and reviewed the bids to ensure that they met the ITB requirements; and

WHEREAS, pursuant to the terms of the ITB, the City reserves the right to award separate contracts to multiple Bidders or one contract to one Bidder and the Chemicals will be provided on an as needed basis; and

WHEREAS, the Division reviewed the bids submitted by Shrieve Chemical Company, LLC (“Shrieve”) and Interacid North America, Inc. (“Interacid”); and

WHEREAS, after reviewing the bids from Shrieve and Interacid, it was determined by City staff that it would be in the best interest of the City to award the ITB to both vendors, with Shrieve, as the primary vendor, and Interacid as the secondary vendor, with the understanding that if Shrieve cannot fulfill a particular request from the City, then the City may utilize Interacid; and

WHEREAS, the aggregate cost for the Chemicals to the City on an annual basis shall not exceed \$226,660.00; and

WHEREAS, the Division recommends that the City Commission approve the award of the Chemicals on an as needed basis to Shrieve, as the primary vendor, and Interacid, as the secondary vendor, and authorize the execution of contracts with Shrieve and Interacid for three-year terms with three additional one-year renewal options.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DEERFIELD BEACH, FLORIDA, AS FOLLOWS:

Section 1. The above referenced “Whereas” clauses are true and correct and made a part of this Resolution.

Section 2. The City Commission hereby approves the award of ITB to Shrieve, as the primary vendor, and Interacid, as the secondary vendor.

Section 3. The City Manager is hereby authorized to execute contracts with Shrieve and Interacid for three-year terms with three additional one-year renewal options in an aggregate total annual amount not to exceed \$226,600, based upon the terms and conditions of the ITB, together with such additional terms and conditions as are acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney

Section 4. This Resolution shall become effective immediately upon adoption.
