A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A MEMORANDUM OF UNDERSTANDING WITH THE FRATERNAL ORDER OF POLICE, LODGE 24, AMENDING ARTICLE 27 OF THE 2022-2025 COLLECTIVE BARGAINING AGREEMENT.

WHEREAS, the City and the Fraternal Order of Police ("FOP") entered into a Collective Bargaining Agreement ("CBA") for the period from October 1, 2022 through September 30, 2025; and

WHEREAS, the parties desire to revise Article 27 of the CBA, UNIFORMS AND UNIFORM CLOTHING AND MAINTENANCE ALLOWANCE; and

WHEREAS, the City and FOP negotiated the attached Memorandum of Understanding ("MOU") that provides an allowance to maintain uniforms and addresses uniforms for specialized units, promotions, and replacements; and

WHEREAS, funding for this MOU is available in the FY 2024 Operating Budget and will be budgeted in subsequent fiscal years' operating budgets, subject to approval and adoption by the City Commission; and

WHEREAS, the MOU shall become effective as of the date of ratification by both parties.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of an MOU with the FOP amending the terms of the CBA with changes to Article 27, Uniforms and Uniform Clothing and Maintenance Allowance.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
