- 1) Department/Division involved – Dept. of Development Services/Community Development Division
- 2) Type of Agreement – CDBG Grant Agreements
- 3) Method of Procurement (RFP, bid, etc.) – n/a
- 4) Term of Contract:
  - a) initial – Program Year 2021/2022
  - b) renewals (if any) – none
  - c) who exercises option to renew – n/a

- 6) Termination Rights – (a) Agreement is contingent upon availability of funds. If funds are not available, then the Agreement shall terminate upon no less than 24 hour notice in writing to the subgrantee; (b) if the subgrantee fails to commence work within three months from the date of execution of the Agreement, or fails to timely fulfill in a timely manner its obligations, or subgrantee violates the terms of the Agreement, the City has the right to terminate the Agreement or suspend payment by written

notice and specifying the effective date of such suspension or termination at least five days before the effective date; and (c) either party may terminate upon 30 days' notice and stating the reason for such termination.

- 7) Indemnity/Insurance Requirements – Subgrantees indemnify pursuant to Article IX of the Agreement.
- 8) Scope of Services – See Exhibit “A” of each agreement. Each of the subgrantees shall provide specific services and programs in accordance with their programs outlined in their scope of services.
- 9) Other Significant Provisions: (a) Subgrantees are required to invoice the City for all funds allocated to their projects by October 7, 2022; (b) Subgrantees are required to provide quarterly progress reports; and (c) the Department will carry out periodic monitoring and evaluation activities based upon the Risk Analysis performed by the Department.
