A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, UPDATING THE COMPREHENSIVE SCHEDULE OF FEES TO SUPPORT THE "PARKING PAYMENT IN LIEU OF PROVIDING PARKING" PROGRAM.

WHEREAS, the City Commission acknowledges the need to continually review and update the Comprehensive Schedule of Fees to align with evolving community needs; and

WHEREAS, in 1994, the City established a program known as the "Parking Payment in Lieu of Providing Parking" program (the "Program"), codified in Section 7.4 of the Zoning and Land Development Regulations; and

WHEREAS, the Program allows certain properties that are not able to provide onsite parking to pay specified amounts into a City fund to be used by the City to construct new parking spaces for the public; and

WHEREAS, on August 30, 2023, the City Commission approved Resolution R-2023-258, which established a tentative fee of \$40,0000.00 per parking space; and

WHEREAS, on November 1, 2023, the City Commission approved the Comprehensive Schedule of Fees by Resolution R-2023-342 that included the tentative fee of \$40,000.00 related to the Program; and

WHEREAS, City staff recommends that in accordance with City policy, the fees collected under the Program be calculated as provided in the Comprehensive Schedule of Fees and to increase the fee from \$40,000.00 per parking space to \$50,000.00 per parking space.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That the Comprehensive Schedule of Fees approved on November 1, 2023 by Resolution R-2023-342 is amended to include the following fees related to the Parking Payment in Lieu of Providing Parking Program:

1. \$50,000.00 per parking space
