A RESOLUTION OF THE HOLLYWOOD, FLORIDA, COMMUNITY REDEVELOPMENT AGENCY ("CRA"), APPROVING AND AUTHORIZING THE APPROPRIATE CRA OFFICIALS TO ISSUE A PURCHASE ORDER FOR THE PURCHASE OF BOLLARDS FROM LANDSCAPE FORMS, INC. IN AN AMOUNT UP TO \$45,933.19 AND TO ISSUE A PURCHASE ORDER FOR THE PURCHASE OF BOLLARDS FROM BARRIER1 SYSTEMS, LLC IN AN AMOUNT UP TO \$126,474.00 IN ACCORDANCE WITH SECTION 38.41 (C)(9) OF THE PROCUREMENT CODE. (BEST INTEREST)

WHEREAS, the Hollywood, Florida Community Redevelopment Agency ("CRA") desires to purchase 99 bollards; and

WHEREAS, it is the best interest of the CRA and the City to enhance security of pedestrians throughout the reconstructed streetscape of Hollywood Boulevard between North 21st Avenue and State Road 5 (Young Circle/Federal Highway/US1); and

WHEREAS, the reconstructed Hollywood Boulevard included bollards along the sidewalk behind parallel parking spaces; and

WHEREAS, the CRA and City of Hollywood Police Department evaluated the existing conditions of the corridor and prepared recommendations to enhance security of identified vulnerable locations; and

WHEREAS, the recommendations increase the number of bollards along the corridor by 99; and

WHEREAS, the CRA desires to purchase bollards from two vendors: Landscape Forms, Inc. and Barrier1 Systems, LLC; and

WHEREAS, the purchase of 49 bollards from Landscape Forms, Inc. will match the existing bollard along Hollywood Boulevard; and

WHEREAS, the CRA staff researched the market for 50 bollards and found that Barrier1 Systems, LLC provides such bollards with a sleeve and at the lowest cost and with a shorter lead time than other vendors; and

WHEREAS, the enhanced improvements for the project will be in alignment with the design and materials utilized in the recently completed Hollywood Boulevard reconstructed streetscape; and WHEREAS, Section 38.41(C)(9) of the Procurement Code states that when the City Commission declares by a five-sevenths affirmative vote that competitive bidding and competitive proposals are not in the best interest of the City, such purchases are exempt from competitive bidding and competitive proposal requirements; and

WHEREAS, the Executive Director of the CRA and Chief Procurement Officer recommend that the CRA Board authorize the appropriate CRA officials to approve the issuance of a Purchase Order to Landscape Forms, Inc. in an amount up to \$45,933.19 and the issuance of a Purchase Order to Barrier1 Systems, LLC in an amount up to \$126,474.00; and

- NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

- <u>Section 2</u>: That it approves and authorizes the issuance of a Purchase Order with Landscape Forms, Inc. in an amount up to \$45,933.19, together with such non-material changes as may be subsequently agreed to by the Executive Director of the CRA and approved as to form by the CRA's General Counsel.
- <u>Section 3</u>: That it approves and authorizes the issuance of a Purchase Order to Barrier1 Systems, LLC in an amount up to \$126,474.00, together with such non-material changes as may be subsequently agreed to by the Executive Director of the CRA and approved as to form by the CRA's General Counsel.
- <u>Section 4</u>: That it approves and authorizes the Executive Director to execute all applicable agreements and documents to implement the Hollywood Boulevard Security Bollards Project.
- <u>Section 5</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
