ANSWER: Over the past three years, I have been closely monitoring South Florida's housing stock, with a particular focus on Hollywood. After reviewing the 2022 Broward County Affordable Housing Needs Assessment published by FIU, it is clear that several key supply and demand factors are impacting the availability and production of affordable housing in our city. Since the pandemic, Hollywood has struggled to keep pace with dramatic shifts in the housing market. Investor purchases have surged, reducing the availability of homes for local buyers and long-term renters. At the same time, increasing renter demand, historically low rental vacancy rates, and skyrocketing rent prices have made it nearly impossible for working-class residents to secure stable housing. Compounding these challenges is the issue of stagnant wages. Hollywood's economy relies heavily on the tourism and service industries, yet many of the workers who sustain this critical sector can no longer afford to live in the city they serve. Without targeted policy interventions—such as incentivizing affordable housing development, implementing tenant protections, and addressing wage disparities, Hollywood risks losing the very people who keep its economy thriving.

This gap in information creates unnecessary obstacles that prevent individuals and families from making informed decisions about their housing needs.

Everyone, regardless of background or circumstance, deserves to understand their rights and opportunities in order to build stable and secure lives. Through my work in affordable housing advocacy, I aim to break down these barriers and ensure that fair housing is truly equitable and accessible for all.
- 5. What role does housing diversity play in Hollywood's economic health?

  ANSWER: Housing diversity is critical to Hollywood's economic health, resilience, and long-term growth. As the 2022 Broward County Affordable Housing Needs Assessment highlights, a diversified housing stock strengthens the entire county and makes Hollywood more adaptable to economic fluctuations. Currently, 93% of Broward County residents cannot afford the median sale price (\$590,000) of a single-family home, putting immense pressure on renters and limiting homeownership opportunities. Hollywood's economy—and that of Broward County—relies heavily on service industry workers in Leisure & Hospitality, Healthcare, and Retail, as well as professionals in public institutions such as hospitals, public schools, and colleges. Without affordable housing options, these essential workers are forced to live far from their jobs, increasing commuting costs, reducing economic stability, and making it harder for businesses to attract and retain talent.

Beyond economic growth, housing diversity directly impacts educational and health outcomes. Research from Johns Hopkins University (2016) found that children in families spending around 30% of their income on housing had significantly higher math and reading test scores than those in households spending over 50%. Additionally, income insecurity—often tied to housing instability—leads to increased public costs in healthcare, emergency services, and social programs, placing further strain on local and state governments.

To ensure Hollywood's long-term economic health, we must prioritize policies that expand housing options across income levels. By investing in diverse, affordable housing, Hollywood can strengthen its workforce, improve educational outcomes, and reduce the social costs associated with housing insecurity, ultimately fostering a more sustainable and resilient economy.
