- WHEREAS,** DR. MICHELLE HINTZ, A LICENSED PSYCHOLOGIST AND BOARD-CERTIFIED MUSIC THERAPIST, IS THE FOUNDER AND CHIEF EXECUTIVE OFFICER OF THE CADENZA CENTER FOR PSYCHOTHERAPY AND THE ARTS.
