
POLICY STATEMENT:

The purpose of the Enhanced Marine Law Enforcement Grant (EMLEG) program is to provide ways and means of improving boating safety in Broward County by enhancing or supplementing marine law enforcement activities and improving boating safety education. Attached is a list of the areas that the Broward County Marine Advisory Committee (MAC) feels are in need of enhanced marine law enforcement or boating safety education. It is desired that law enforcement agencies utilize the Local Option Vessel Registration Fee approved by the Board of County Commissioners to supplement existing services in their area of jurisdiction. Coordination with other law enforcement or educational agencies that have jurisdiction in Broward County is encouraged, and may be necessary, to enable the applicant agency to provide the needed enhanced coverage as desired. Innovative projects to improve boating safety in Broward County are enthusiastically encouraged.

PROJECT DESCRIPTION:

The Marine Unit is assigned to the Special Operations Division and consists of a Lieutenant, Sergeant and one full-time Marine Officers. The primary goal of the Hollywood Police Department's Marine Unit is the safe operation of vessels within the waterways in the jurisdictional limits of the City of Hollywood. The major emphasis of the Officers assigned to the EMLEG patrols will be to conduct boater safety inspections and address environmental and regulatory concerns. Enforcement will be used at the Officer's discretion for violations which demonstrate blatant disregard for safety, environmental and regulatory controls. The principal goals of EMLEG patrols are to reduce vessel accident, reduce water violations and educate the boating community.

EMLEG ZONE VIII, DANIA BEACH BOULEVARD BRIDGE TO HALLANDALE BOULEVARD BRIDGE

The City of Hollywood Police Department agrees to provide Enhanced Marine Patrol for the area defined as EMLEG ZONE VIII Dania Beach Boulevard to Hollywood South Boundary. These enhanced marine patrols will be conducted commencing October 1, 2021 and concluding September 30, 2022. During the 2021-2022 fiscal year, the City of Hollywood Police Department will provide an additional sixteen hours of marine patrol coverage on weekends and on EMLEG covered holidays.

AGGRESSIVE MARINE PATROL, EMLEG ZONE VIII

The City of Hollywood Police Department agrees to utilize the allotted Aggressive Marine Patrol hours for night time Marine Patrol, Boater Safety Inspections, Manatee Zone education and enforcement. Boating Under the Influence operations and any other marine safety concerns. These hours will be utilized to add additional boats not regularly scheduled or to provide additional hours of coverage in areas of concern.

Boaters Safety Education is conducted in conjunction with the Marine Unit Officers daily duties via vessel checks and stationary boat ramp checks. Both Officers have successfully completed a Florida Safe Boating Course and have Boating Safety Education Cards. Both Marine Unit Officers are Certified Dive Team Members. The Marine Unit conducts in-house training in accordance with the Training and Professional Standards Unit as required by Department Policy. Future training needs are continually evaluated and will be addressed if practical.

4. DESCRIBE HOW THE PROPOSED GRANT PROJECT WOULD IMPROVE BOATING SAFETY IN BROWARD COUNTY.

The EMLEG grant funds provided have allowed the Hollywood Police Department to greatly expand the days and hours of Police Marine coverage on the waterways within the specified zones and during the times of concern. The primary goal of the Hollywood Police Department's Marine Unit is the safe operation of all vessels within the waterways of the City of Hollywood. The major emphasis of the Officers assigned to the EMLEG patrols will be to provide information to educate boaters on safety, environmental and regulatory concerns and the safe operation of vessels within the waterways of the City of Hollywood. Enforcement will be used at the Officer's discretion for violations that demonstrate blatant disregard for the safety, environmental and regulatory controls. The principal goal of the EMLEG patrols is to reduce accidents and violations on the waterways and to educate the boating public. In addition, the Aggressive Marine Patrol hours allow for night coverage, as well as the flexibility to add additional marine resources to address safety, education, environment or enforcement concerns. These hours are in addition to the normal scheduled hours and enhanced patrol in Zone VIII.

DESCRIPTION OF PROJECT TYPES

INNOVATIVE LAW ENFORCEMENT PROGRAMS: This project category is set up to allow applicants to come up with unique law enforcement programs to improve boating safety in Broward County above and beyond existing levels of marine law enforcement. Applicants who submit this type of grant proposal are encouraged to develop new and innovative programs.

ENHANCED MARINE LAW ENFORCEMENT: This project category allows applicants to apply for funding for one year, to enhance/supplement the existing level of marine law enforcement in the applicant's jurisdiction. **This grant may not be used to replace the existing funding level of marine law enforcement.** This grant may not fund more than fifty (50) percent of marine patrol hours during the given year. Applicants are encouraged to submit proposals to utilize the *AZones and Times of Concern*.

POLICE MARINE EQUIPMENT: This project type would allow applicants to apply for new equipment or to replace equipment spent implementing the requirements of the EMLEG Program=s marine law enforcement not funded in the applicant=s budget. EMLEG will not fund the general maintenance of police marine equipment.

INNOVATIVE BOATING SAFETY/EDUCATION/PUBLIC INFORMATION: This category is set up to allow applicants to develop unique educational programs to improve the instruction of boating safety in Broward County above and beyond existing levels of educational standards. Applicants, who submit this, or a similar type activity as a grant proposal, are encouraged to develop new and innovative programs.

BOATING SAFETY/EDUCATION/PUBLIC INFORMATION: This category is not limited to applicants who are non-enforcement agencies. This project type would allow the applicant to apply to fund projects which would improve boating safety in Broward County through boating safety training, public information, channel marking and limited signage, or other types of projects which result in improved boating safety in Broward County.

EDUCATIONAL/SAFETY/PUBLIC INFORMATION EQUIPMENT: This project type would allow applicants to apply for new equipment or to replace equipment that was worn out due to the EMLEG Program for boater safety education that is not funded in the applicant=s budget. EMLEG will not fund the general maintenance of any educational equipment.
