A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT, IF AWARDED, THE FLORIDA DEPARTMENT OF STATE 2026 - 2027 GENERAL PROGRAM SUPPORT GRANT IN THE AMOUNT OF \$75,000.00 FOR THE ARTSPARK CONCERT SERIES; AUTHORIZING THE REQUIRED 1:1 MATCHING FUNDS TO BE PAID FROM DEPARTMENT OF PARKS, RECREATION AND CULTURAL ARTS SPECIAL EVENTS BUDGET; FURTHER AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL APPLICABLE GRANT DOCUMENTS AND AGREEMENTS; AMENDING THE FISCAL YEAR 2026 ADOPTED OPERATING BUDGET.

WHEREAS, the Department of Parks, Recreation and Cultural Arts ("PRCA") determined the need for additional concerts at ArtsPark; and

WHEREAS, the Florida Department of State, Division of Arts and Culture 2026 – 2027 General Program Support ("DAC-GPS") grant funds general program activities taking place within the grant period of July 1, 2026, through June 30, 2027; and

WHEREAS, the DAC-GPS grant seeks \$75,000.00 for the ArtsPark Concert Series; and

WHEREAS, the DAC-GPS grant requires a 1:1 match from the grant recipient; and

WHEREAS, PRCA will provide the matching funds allocated within PRCA's general fund Special Events operational budget; and

WHEREAS, the Director of PRCA recommends the City Commission authorize appropriate City officials to accept, if awarded, the DAC-GPS grant for the ArtsPark Concert Series; and

WHEREAS, the Fiscal Year 2026 Operating Budget of the City of Hollywood was adopted and approved by the City Commission pursuant to Resolution R-2025-335 at the 2nd Public Budget Hearing on September 25, 2025; and

WHEREAS, this Resolution seeks to amend the budget as detailed in the attached Exhibit "1," if the grant is awarded.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That the City Manager is authorized to accept the grant, if awarded, provided that the City Manager shall have the discretion to refuse the grant in those circumstances where he determines it is in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the grant.

Section 3: That it approves and authorizes the execution, by the appropriate City Officials, of the agreement with Florida Department of State, Division of Art & Culture, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4: That it authorizes the appropriate City officials to execute all applicable grant documents and agreements in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 5: That the Department of Financial Services is authorized to create and establish in the appropriate fund the necessary accounts to recognize the receipt of grant funding and to appropriate grant related funding as may be required.

Section 6: That the amendments to the Fiscal Year 2026 Operating Budget for the Fiscal Year beginning October 1, 2025, and set forth in detail in the attached Exhibit "1," are adopted and authorized as Amendments to the Operating Budget of the Special Programs Fund (Fund111).

Section 7: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
