A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING RESOLUTION NO. R-2010-171 IN ORDER TO ESTABLISH A NEW PARKING PERMIT AND FEE IN THE DOWNTOWN HOLLYWOOD BOULEVARD PARKING LOT LOCATED AT 2014 HOLLYWOOD BOULEVARD AND ESTABLISHING THE HOURS FOR PARKING WITHIN SAID PARKING LOT.

WHEREAS, on June 16th, 2010, the City Commission passed and adopted Resolution No. R-2010-171 which established fees for parking permits, valet permits, on-street parking, and garage parking; and

WHEREAS, businesses requested permits be allowed for parking in the Hollywood Boulevard parking lot located at 2014 Hollywood Boulevard from 7:00 AM to 7:00 PM Monday through Saturday with paid metered parking allowed from 7:00 PM to 7:00 AM Monday through Saturday and all day Sunday; and

WHEREAS, the Parking Administrator has been directed to establish a new and separate permit, along with the associated fee, for parking in the above named lot for business employees in the immediate vicinity.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That Exhibit "A" of Resolution No. R-2010-171 is amended to establish a Permit for the Downtown Hollywood Boulevard Parking Lot located at 2014 Hollywood Boulevard during the set hours, as more specifically set forth in the attached Exhibit "A".

Section 3: That this Resolution shall be in full force and effect upon its passage and adoption.
