DRAFT 2024 - 2028 CONSOLIDATED PLAN
AND 2024 ANNUAL ACTION PLAN**

NOTICE is given that a draft of the 2024-2028 Consolidated Plan and the Program Year (PY) 2024 Annual Action Plan (AAP) for the City of Hollywood will be available for a thirty (30) day public comment and review period. Notice is also given that two Public Hearings will be held.

The 2024-2028 Consolidated Plan sets five-year priority needs and goals for the City's entitlement programs funded by the U.S. Department of Housing and Urban Development (HUD). The PY 2024 AAP outlines proposed projects and activities by the City's Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) program to address the identified priority needs and goals in the Consolidated Plan. The city expects to receive an estimated \$1,234,567 in CDBG entitlement funding, and \$220,300 in CDBG program income for a total of \$1,454,867 and \$517,547 in HOME funding from HUD for PY 2024, and \$1,500,000 in HOME program income for a total of \$2,017,547, which begins October 1, 2024 and ends September 30, 2025. 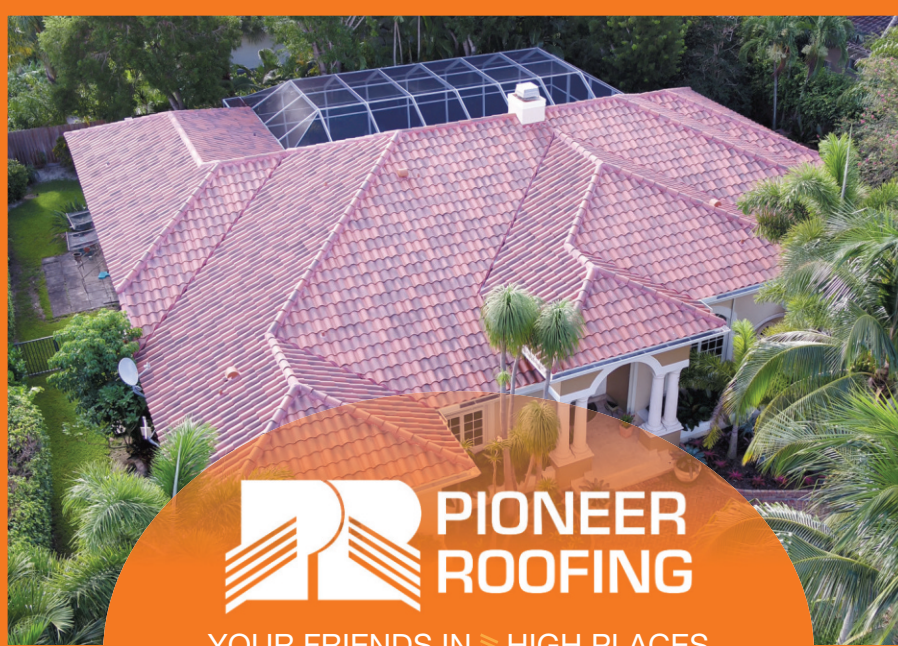

Public Hearings: A public hearing will be held to discuss the draft 2024-2028 Consolidated Plan and 2024 AAP on June 12, 2024, at 6:00 PM at Hollywood City Hall, 2600 Hollywood Blvd. Room 215 and a public hearing to approve the plan will be held before the City Commission on July 3, 2024 at City Hall, in the City Commission Chambers, at 1:00 p.m. or soon thereafter as the agenda permits.
