Project Overview: In March of 2019, the voters approved a General Obligation Bond, which included funding for a new Police Headquarters. The new facility will be built south of the existing facility, on land currently being used for the Orangebrook Golf & Country Club driving range. The current Police Headquarters will remain in use during construction. The new Police Headquarters is envisioned to be approximately 105,000 SF in size, with a secure parking structure for the Police Department staff. The facility will house all necessary police functions. The facility will be designed to accommodate the changing needs of the Police Department for many years to come.

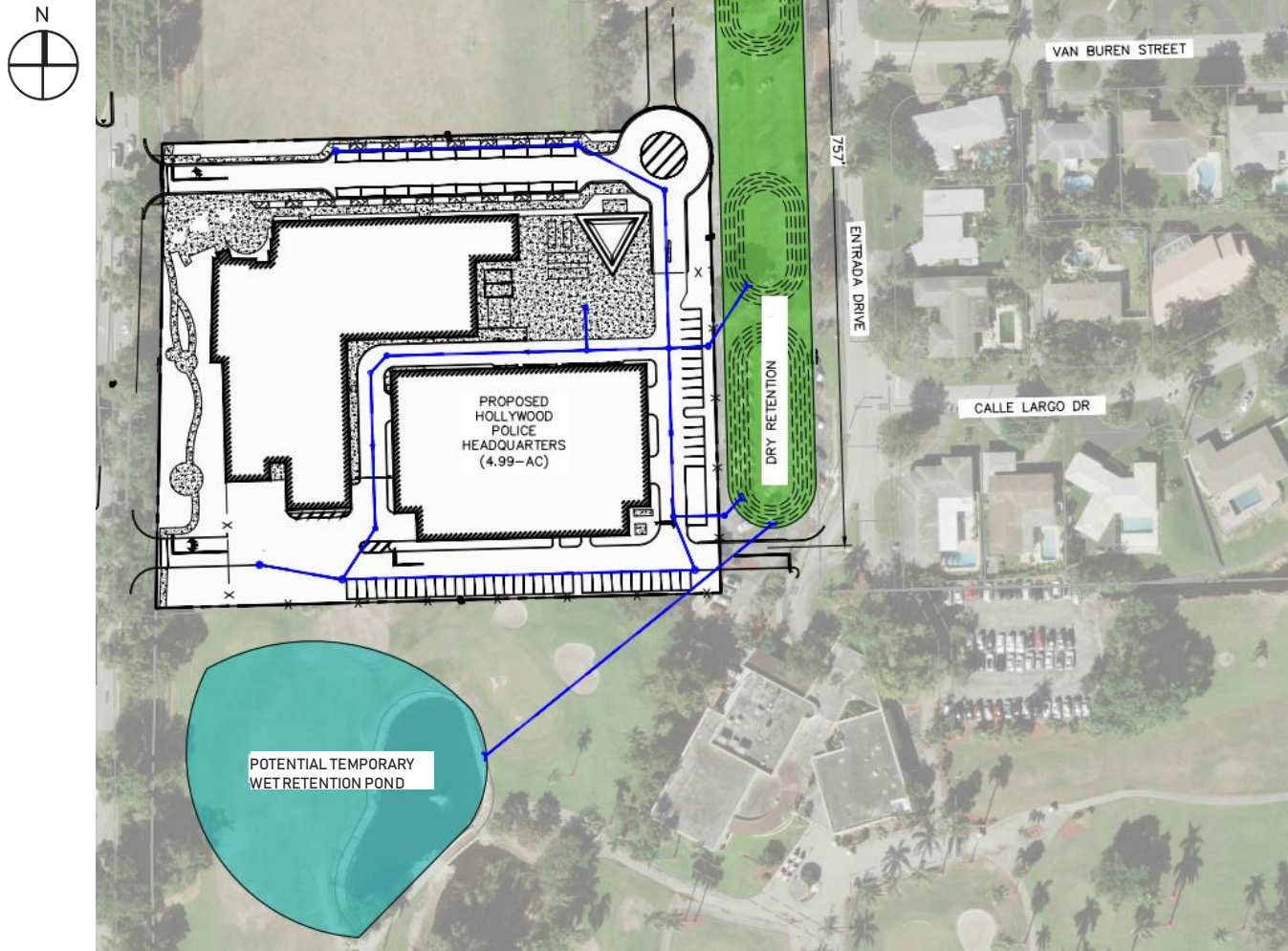
Objective: Design & construct new radio tower to replace existing Police Headquarters Radio Tower

- Existing tower has shown signs of aging and is structurally unable to accommodate the equipment needed to service the City's needs according to a 3rd party analysis performed in May 2015
- New Tower will hold the City's public safety equipment and the City radio equipment
- Existing, aging radio tower will be dismantled and recycled

Update:

- Replacement tower is being engineered using the latest ANSI/TIA-222-Revision H engineering guidelines, benefitting the City and residents with a stronger, safer tower.
- Concept Design phase of proposed Radio Tower is complete, including preliminary FAA approval and geotechnical soil analysis.
- Radio Tower completed PACO review on May 2, 2022.
- Radio Tower has been submitted for Preliminary TAC review as part of the overall New Police Headquarters project.

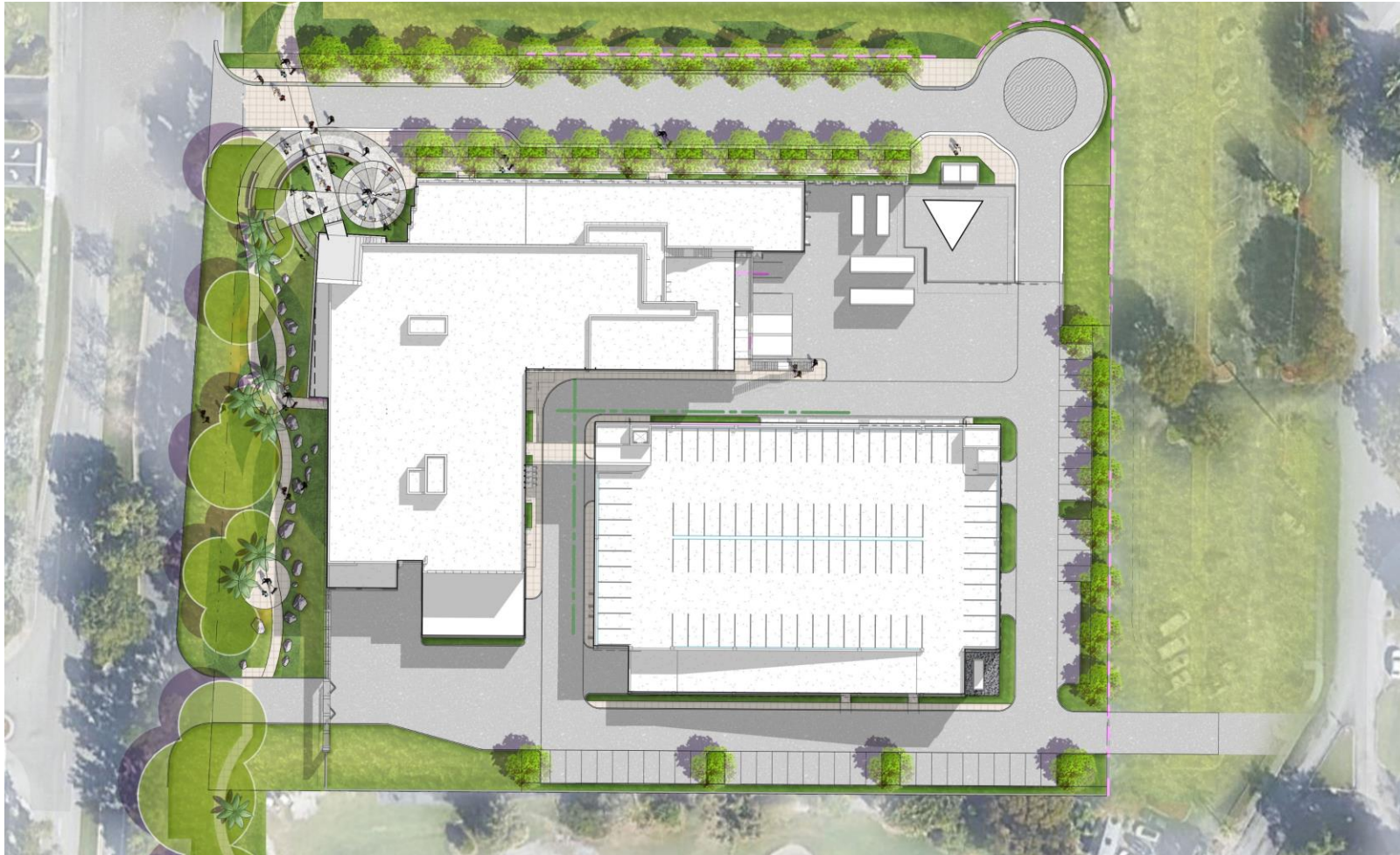

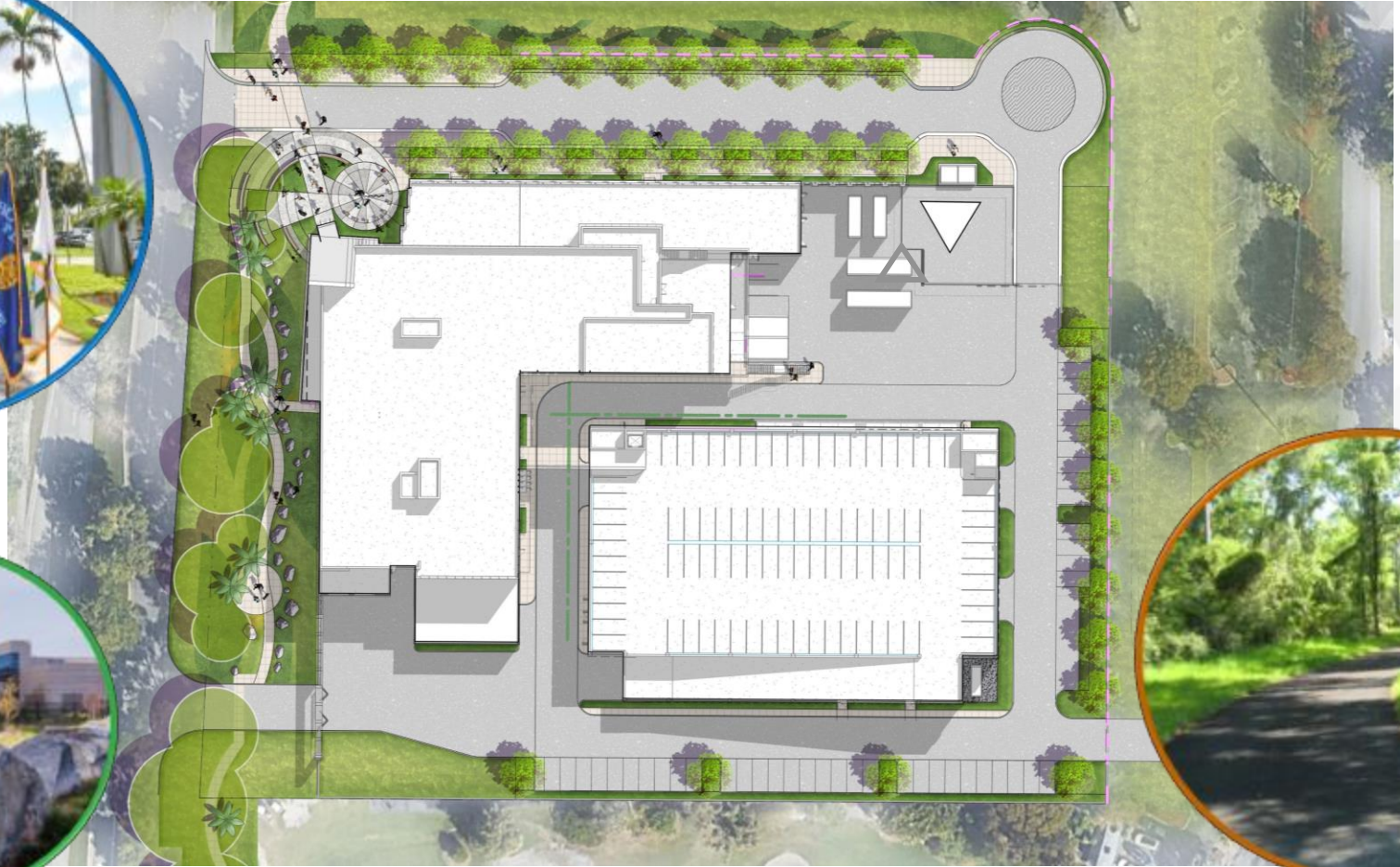

The notes below are based on feedback from attendees and information provided

Yvonne Garth, President of Garth Solutions, opened the meeting and introduced Chris O'Brien, Chief of Police for the City of Hollywood. Chief O'Brien shared his thanks on behalf of city staff for the residents passing the bond referendum to fund the new police headquarters and mentioned the importance of staying within the budget while ensuring a cost-efficient project that is well managed from start to finish. The remaining members of the project team were then introduced.

Project Manager, Heather Guenot, provided the planned timeline of the project and briefly provided residents with a better understanding of what this project will entail from start to finish. She provided information on the feedback given at the last meeting

where there was great emphasis on the need for buffers between the Police Station and Adjacent communities and explained how this feedback had been integrated into the project design. She went on to provide information requested about the linear park and explained that the park would eventually be extended to Hollywood Boulevard once the north side of the parcel is developed.

Architect Ed O'Donnell went through the site plan and the various facility perspectives. He explained that although the rendering does not include the landscape, there is landscaping included in the building/site design.

Major Marino provided information on the community shared space and lobby. He explained that the rooms will serve multiple purposes including community meeting places, as a recreational area for police officers working long hours, and as an emergency center and shelter in the event of natural disasters.

Mr. Karamitsos provided a brief overview of the elements within the design and construction of the new police department headquarters which were meant to address the sustainability aspect as provided in feedback from residents at previous meetings.

Mayor Levy informed the audience that there are preliminary conversations being had between government agencies regarding the possibility of putting a county courthouse at the location. Mayor Levy also mentioned that they are looking at opportunities for synergy in transportation and more transportation enhancement opportunities and confirmed Hollywood Blvd would be a main corridor for this to take place.

Mr. Zadikoff explained that the building would comply with all current building codes and will be constructed to withstand hurricanes and other natural disasters.

Mr. Viola provided information relating to stormwater drainage and the proposed temporary retention pond on the south end near the golf course.

Questions and Answers/Comments from Audience:

Will solar energy be used, or will it be considered down the line if not in the initial design/construction?

Ms. Heran stated that during the current design phase of this project the team has been looking into way to incorporate elements of sustainability and the building will be built to current LEED Silver Standard.

Are there going to be any drainage issues?

Ms. Heran stated that drainage issues and analysis were considered when the designs were being developed.

Will residents be able to use this new location as a safe place where transactions can be done for the exchange of goods, like Offer Up and other services?

Ms. Heran explained that any public spaces can be used for the transactions described.

What will happen to the existing headquarters?

Ms. Heran advised the building would be demolished after the construction of the new police headquarters.

Will the linear path be safe and secure?

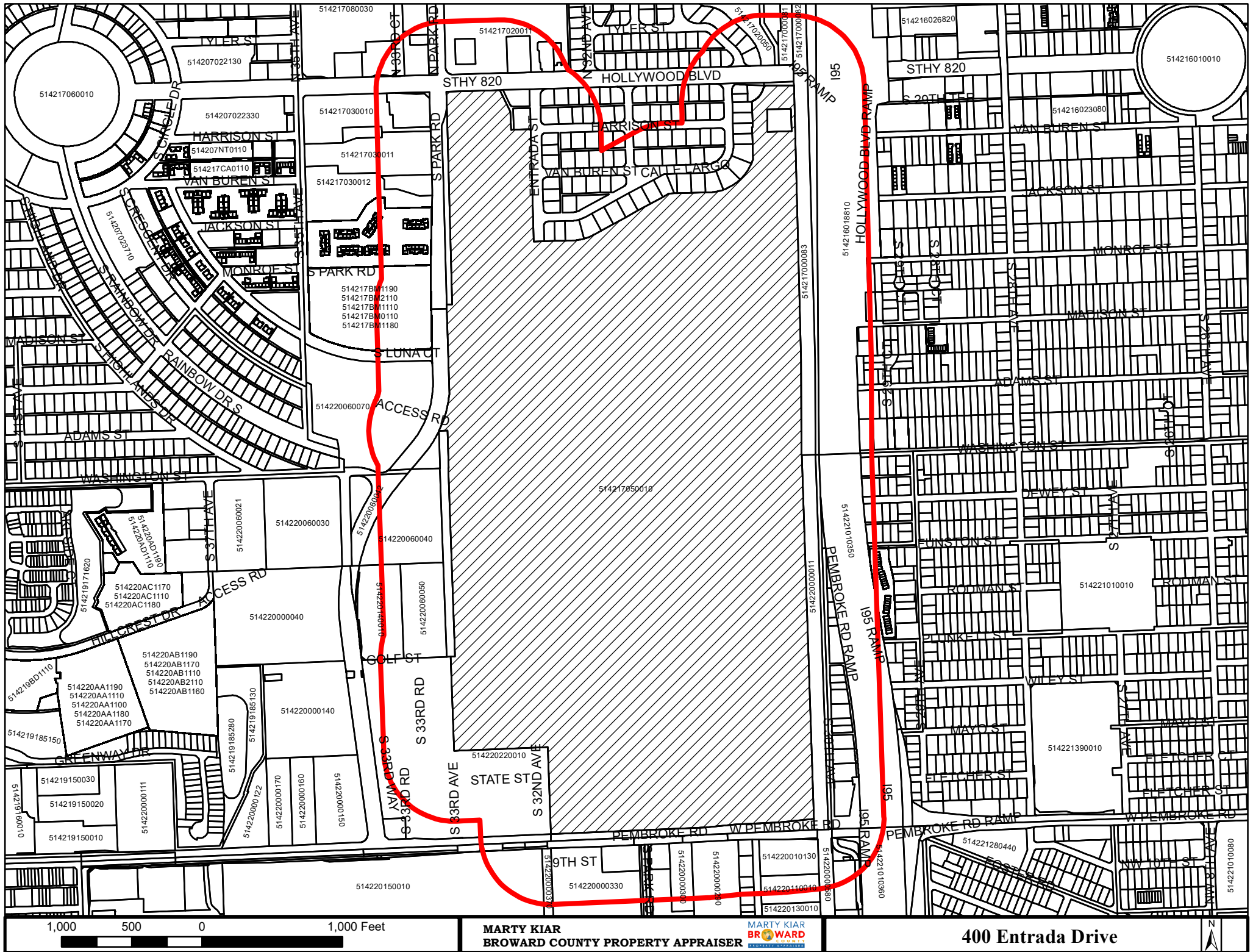
Ms. Heran explained that the police team work diligently to design it in a way that it is secure.

Could the current police headquarters site be turned into an arcade or a movie theater?

Ms. Heran explained that plans for the property outside of demolishing the building have not yet been contemplated by staff. Mayor Levy mentioned that there is a possibility of a county courthouse being put there, or that the location could be utilized for commercial purposes.

A resident expressed their frustration about a pros and cons list not being provided based on the concerns shared in previous meetings along with an explanation as to what was considered and why it was/was not included in the design plans.

Ms. Heran explained the architects work in conjunction and collaboration with the city and are a part of the decision-making process, of which took a total of 8 months to complete. Ms. Heran offered to provide the resident with any of the information and research he needs or felt was not represented.
