A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING THE FISCAL YEAR 2017 ADOPTED OPERATING BUDGET (R-2016-284), AS DETAILED IN THE ATTACHED EXHIBITS 1 - 8, REVISING OPERATING REVENUES, AUTHORIZING BUDGETARY TRANSFERS AND ADJUSTMENTS, REAUTHORIZING AND RE-APPROPRIATING CERTAIN FUNDING; AUTHORIZING THE DEPARTMENT OF FINANCIAL SERVICES TO ESTABLISH ACCOUNTS AS MAY BE NEEDED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, certain routine and periodic budgetary adjustments and transfers are appropriate and necessary; and

WHEREAS, the Fiscal Year 2017 Operating Budget was adopted and approved by the City Commission pursuant to Resolution R-2016-284 at the 2nd public budget hearing on September 28, 2016; and subsequently amended; and

WHEREAS, the transferring of funding between line item accounts is needed to provide funding support for the current fiscal year's budget; and

WHEREAS, operational requirements necessitate certain revisions or amendments to the Adopted Fiscal Year 2017 Budget to properly align funding for various projects since the beginning of the fiscal year; and

WHEREAS, operational and capital requirements necessitate certain revisions to the Adopted Fiscal Year 2017 Budget to promote greater productivity, effectiveness, and efficiency;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD. FLORIDA:

<u>Section 1:</u> That the Amendments to the Operating Budget of the City of Hollywood for the Fiscal Year beginning October 1, 2016, as set forth in detail in Exhibits 1 - 8, attached hereto, and by this reference made a part hereof, are hereby approved, adopted and accepted as Amendments to the Operating Budget of the City of Hollywood Florida, for the Fiscal Year 2017.

<u>Section 2:</u> That the Department of Financial Services is hereby authorized to establish such line item accounts as may be necessary to properly monitor and track expenditures.
