## **Proposed Legislation:**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING A DONATION OF LAW ENFORCEMENT FORFEITURE FUNDS PURSUANT TO FLORIDA'S CONTRABAND FORFEITURE ACT IN SUPPORT OF COMMUNITY ORGANIZATIONS AND LOCAL AGENCIES WHICH PROVIDE DRUG TREATMENT, DRUG ABUSE EDUCATION, DRUG PREVENTION AND AWARENESS, CRIME PREVENTION AND SAFE NEIGHBORHOOD PROGRAMS IN THE AMOUNT OF \$75,500.00.

## Explanation:

This Resolution seeks authorization for the appropriate City Officials to make donations to local community organizations and agencies which provide certain services to the local community from the funding available in the Law Enforcement Forfeiture Fund, "LEFF", as required by §932.7055(5)(c)(3) of the Florida Statutes. Applicable Florida Law requires that each local law enforcement agency acquiring at least \$15,000.00 in forfeited funds pursuant to the Florida Contraband Forfeiture Act donate no less than Fifteen Percent (15%) of Law Enforcement Forfeiture Fund assets during each fiscal year for the support of drug treatment, drug abuse education, drug prevention and awareness, crime prevention and safe neighborhood programs within its jurisdiction. Several local community organizations and agencies have applied for funding through

the Police Department's application process. Upon the review and consideration of local law enforcement officials, nine (9) local organizations or agencies which provide programming or services in compliance with statutory requirements have been selected for funding from Law Enforcement Forfeiture Fund assets. The agencies and amounts are:
