Notice of the public meeting for the Drinking Water State Revolving Fund (DWSRF) Base and Bipartisan Infrastructure Law (BIL) General Supplemental Intended Use Plan (IUP) and Project Priority List, the amended Emerging Contaminants IUP and Project Priority List, Lead Service Line Replacement (LSLR) Funding Project Priority List, and Project Priority List adoptions was published in the Florida Administrative Register, Volume 49, Number 134, on July 12, 2023.

Notice of the public meeting for the Clean Water State Revolving Fund (CWSRF) Water Pollution Control Priority List was published in the Florida Administrative Register, Volume 49, Number 134, on July 12, 2023.

On August 9, 2023, the State Revolving Fund (SRF) Program, under the Florida Department of Environmental Protection (FDEP), held a public meeting both in person and virtually via Microsoft Teams. Andrew Briscoe, Division of Water Restoration Assistance (DWRA), served as Moderator.

Eric Meyers, Program Administrator of the DWSRF, presented and summarized the Department's issues and staff recommendations involving: :

 a) Drafting the State Fiscal Year (FY) 2024 DWSRF Base and BIL General Supplemental IUP and management of the Project Priority List that will be used to apply for the Base and BIL General Supplemental Capitalization Grants from the United States Environmental Protection Agency (U.S. EPA)

- b) Amending the BIL Emerging Contaminant IUP and management of the Project Priority List for FY 2023 and FY2024 that was used to apply for the FY 2023 and FY 2024 BIL Emerging Contaminants Grants from the U.S. EPA; and,
- c) Drafting the BIL LSLR IUP and management of the Project Priority List for FY2024 that will be used to apply for the LSLR Capitalization Grant from the U.S. EPA.

After hearing each of these recommendations, the Moderator asked for public or staff comment. There was no discussion regarding the exhibits presented that changed staff recommendations. No issues were raised. This concluded business regarding management of the DWSRF Project Priority Lists.

The FY 2024 DWSRF Priority Lists for Base and BIL General Supplemental and the respective IUP were adopted. The DWSRF Emerging Contaminant Project Priority List with the amended FY 2023 and FY2024 Intended Use Plan was approved, as was the DWSRF LSL Project Priority List.

After hearing each of these recommendations, the Moderator asked for public or staff comment. There was no discussion regarding the exhibits presented that changed staff revised recommendations. No issues were raised. This concluded business regarding management of the CWSRF Project Priority lists. The recommendations were approved.

EXHIBIT B: For the 8/09/2023 FY 2024 Priority List Adoption Meeting FY2024 CWSRF WATER POLLUTION CONTROL PRIORITY LIST ADOPTION ISSUES AND RECOMMENDATIONS, Ch. 62-503

The DWSRF and CWSRF Project Priority Lists schedule projects to be financed with loans, and grants in the form of principal forgiveness loans from the SRF. The Project Priority Lists are developed annually and adopted by the Department under the provisions of Chapter 62-552 and 62-503, F.A.C. The rules provide for certain list management activities, including but not limited to, removal of projects which have failed to meet document submittal deadlines as required by the rules, authorization of additional funds to projects already on the lists, and the addition of new projects to the lists.

This concluded the public meeting regarding management of the SRF priority lists.

A person whose substantial interests are affected by the Department's proposed agency action may petition for an administrative proceeding (hearing) under Sections 120.569 and 120.57 of the Florida Statutes. The petition must contain the information set forth below and must be filed (received by the clerk) in the Office of General Counsel of the Department at 3900 Commonwealth Boulevard, Mail Station 35, Tallahassee, Florida 32399-3000.

Petitions by the applicants or any of the parties listed below must be filed within twentyone days of receipt of this written notice. Petitions filed by any persons other than those entitled to written notice under Section 120.60(3) of the Florida Statutes must be filed within twenty-one days of publication of the notice or within twenty-one days of receipt of the written notice, whichever occurs first.

Under Section 120.60(3) of the Florida Statutes, however, any person who has asked the Department for notice of final agency action may file a petition within twenty-one days of receipt of such notice, regardless of the date of publication on the Department's website.

The petitioner shall mail a copy of the petition to the applicant(s) at the address indicated at the end of this order at the time of filing. The failure of any person to file a petition within the appropriate time-period shall constitute a waiver of that person's right to request an administrative determination (hearing) under Sections 120.569 and 120.57 of the Florida Statutes, or to intervene in this proceeding and participate as a party to it. Any subsequent intervention (in a proceeding initiated by another party) will be only at the discretion of the presiding officer upon the filing of a motion in compliance with rule 28-106.205 of the Florida Administrative Code.

A petition that disputes the material facts on which the Department's action is based must contain the following information:

- a) The name, address, and telephone number of each petitioner, the Department's notice identification number and the county in which the subject matter or activity is located.
- b) A statement of how and when each petitioner received notice of the agency decision.
- c) A statement of how each petitioner's substantial interests are affected by the Department action.

- d) A statement of the material facts disputed by the petitioner, if any.
- A statement of facts that the petitioner contends warrant reversal or modification of the Department action.
- f) A statement of which rules or statutes the petitioner contends require reversal or modification of the Department action.
- g) A statement of the relief sought by the petitioner, stating precisely the action that the petitioner wants the Department to take.

A petition that does not dispute the material facts on which the Department's action is based shall state that no such facts are in dispute and otherwise shall contain the same information as set forth above, as required by Rule 28-106.301, F.A.C.

Because the administrative hearing process is designed to formulate final agency action, the filing of a petition means that the Department's final action may be different from the position taken by it in this notice. Persons whose substantial interests will be affected by any such final decision of the Department have the right to petition to become a party to the proceeding, in accordance with the requirements set forth above.

Mediation under Section 120.573 of the Florida Statutes is not available for this proceeding. This action is final and effective on the date filed with the Agency Clerk unless a petition is filed in accordance with the above. Upon the timely filing of a petition this action will not be effective until further action of the Department.

Any party to the order has the right to seek judicial review of it under Section 120.68 of the Florida Statutes, by the filing of a notice of appeal under rule 9.110 of the Florida Rules of Appellate Procedure with the Clerk of the Department in the Office of General Counsel, Mail Station 35, 3900 Commonwealth Boulevard, Tallahassee, Florida, 32399-3000, and by filing a copy of the notice of appeal accompanied by the applicable filing fees with the appropriate district court of appeal. The notice of appeal must be filed within 30 days after this order is filed with the Clerk of the Department.

3) For the combined Base and Bipartisan Infrastructure Law (BIL) General Supplemental Program, the Department has determined that sufficient funds in the amount of \$190 million will be available in SFY 2024 to allow a segment cap amount of \$47.5 million. Project increase requests on Tier 1 and new projects on Tier 3 that have been certified by staff as ready-to-proceed are eligible for listing on the fundable portion of the priority list subject to the segment cap. With an estimated \$37,200,000 in Principal Forgiveness (PF) funds available from the BIL General Supplemental Fund plus the \$4,738,000 in PF funds available from the Base Fund, no segment cap for PF has been set with one half of the total of \$41,938,000 in PF available at this meeting. The remaining PF shall be available again at the February 2024 Priority List Meeting.

4) Pursuant to Ch. 62-552.300(2)(e), F.A.C., a financially disadvantaged community with a service area population of 10,000 persons or greater is eligible for 20% principal forgiveness for a construction loan if dollars are available after funding all eligible financially disadvantaged small communities, which was done in Issue 3 above. Since there are principal forgiveness dollars remaining, large, disadvantaged communities can be considered.

The Program Administrator has determined that funds are available and the late projects will be elevated and to the fundable portion of the priority list.

- 7) For the Emerging Contaminants (EC) funding, the Department has determined that an adjustment to the combined SFY 2022 and SFY2023 Intended Use Plan and associate Priority Lists is necessary to expeditiously use the BIL Emerging Contaminants Grant. In Federal Fiscal Year (FFY) 2022 Florida's allotment of the BIL's EC Funding was \$29,741,000.
 - a. The BIL requires states to provide 100% of this capitalization grant amount as additional subsidization (i.e., principal forgiveness). In order to achieve this, DWSRF has determined in accordance with 62-552.300(8), F.A.C., that an exception to Rules 62-552.300(1)(b), 62-552.300(1)(d), 62-552.300(2), and 62-552.500, F.A.C., shall be granted to projects receiving this funding and this funding only (does not apply to base and general supplemental cap grants). These exceptions meet the intent of Congress that communities needing to address emerging contaminants in drinking water will receive this funding fully subsidized with no loan component.
 - b. Selected Project Summary:
 - i. The Town of Belleair has detected concentrations of PFAS (10 parts per trillion [ppt]) in raw water samples upstream of the plant, where the supply pipes converge. The town of Belleair is planning to evaluate treatment technologies such as ion-exchange, reverse osmosis, and granular activated carbon to reduce PFAS concentrations at the WTP and complete the design.

- ii. The Riviera Beach Utility Special District has identified PFAS in the raw water (average concentration of 26.5 ppt) and in the finished water (38 ppt [2016]). The Special District is planning to evaluate decommissioning the existing lime softening process and installing either a three-step ion exchange, a two-step ion exchange and pellet softening, and a nanofiltration and reverse osmosis membrane process as part of upgrading the WTP to reduce PFAS concentrations.
- iii. The City of Sanford has detected levels of 1,4 Dioxane above Florida's Health Advisory Level (HAL) of 0.35 micrograms per liter (μg/L) in several of their raw water supply wells, causing the City to severely reduce production from these wells in order to continue to provide safe drinking water to its customers.
- iv. The City of Pompano Beach has detected PFAS in the west well field (average concentration of 55.4 ppt), east wellfield (26.1 ppt), and the composite raw water (36.95 ppt) that supplies the water treatment plant. The City is planning to evaluate the two existing treatment processes (conventional lime softening and nanofiltration) as well as other treatment technologies that may be incorporated into the process.
- v. The City of Hollywood has detected PFAS in the Chaminade wellfield (51.8 ppt), Southern wellfield (43.5 ppt), the source surface water (21.2 ppt), the membrane raw water (26.7 ppt), lime softening process (40.9 ppt and 52.9 ppt) and the point of entry (24.1 ppt) into the distribution system. The City is planning to evaluate the existing water treatment processes that may be upgraded to reduce PFAS concentrations.
- vi. The City of Delray Beach has identified PFAS in the raw water and point of entry (POE) for the finished water (average concentration of 39.4 ppt) into the distribution system. The City is planning to evaluate a new membrane water treatment plant that can meet the City's long term goals and compliance.
- vii. Palm Beach County has identified PFAS associated with four WTPs (Number 2, 3, 8, and 9). WTP Number 2 and 8 are lime softening facilities with limited PFAS removal. WTPs Number 3 and 9 are membrane facilities that have demonstrated a reduction in PFAS. The County is planning to evaluate the additional treatment at the lime softening facilities and nanofiltration at the membrane facilities to reduce PFAS concentrations.

- 8) For the BIL Lead Service Line (LSL) Replacement funding, the Department has determined that sufficient funds in the amount of the budget authority of \$111.6 million are available. For FFY 2023, the EPA has allotted Florida \$254.7 million. Additional budget authority is being requested to assist additional communities and public water systems.
 - a. The BIL requires states to provide 49% of this capitalization grant amount as additional subsidization (i.e., principal forgiveness). In order to achieve this, Florida DWSRF has determined in accordance with 62-552.300(8), Florida Administrative Code (F.A.C.), that an exception to Rules 62-552.300(1)(b), 62-552.300(1)(d), 62-552.300(2), 62-552.300(4)(j), 62-552.300(6), 62-552.500, 62-552.680, 62-552.700(2), 62-552.700(3), and 62-552.700(4), F.A.C., shall be granted to projects receiving this funding and this funding only (does not apply to base and general supplemental cap grants).

This exception meets the intent of Congress that communities needing to identify and replace LSLs will receive this funding 49% subsidized with a 51% loan component.

b. Projects previously listed on the waiting list and new project requests on Tier 3 have been certified by staff as ready-to-proceed and are eligible for listing on the fundable portion of the priority list. Based on the current budget authority, there is an estimated \$54,684,490 in Principal Forgiveness (PF) funds available from the BIL LSL. Projects previously listed and on the waiting list or new projects are eligible as follows:
