

**Reason for the proposed name change/designation:**

Currently at Rotary Park there are 6 baseball fields and 2 softball fields. Each baseball field has a name and the two softball fields are designated "Rotary Field 1 & Rotary Field 2". On December 8, 2013 we lost a dear friend and fellow board member David Shull. David Shull was diagnosed with colon cancer earlier in 2013. David is survived by his wife Suzy, daughter Dayna 17, and son David 14. Both Dayna and David continue to support the program by either umpiring or playing. Suzy continues to serve on the Board of Directors. During our last board meeting, the Board of Directors unanimously voted to begin the application process to change the name of Rotary Field 2 (a softball field within Rotary Park) to David Shull Field. I Jerry Engelhard, President of Youth Sports of Hollywood, and the Board of Directors, respectfully request this application to be approved.

**Nominee's Contributions or accomplishments:**

David Shull 2/16/1956 - 12/8/2013 (57 Years old)

David and Suzy Shull had been married for over 20 years. David lived in Hollywood throughout his entire life. David has coached/umpired at Rotary Park for over 12 years. He coached his daughter Dayna in softball and his son David in baseball. He has even coached teams when no other coaches were available to coach. David and Suzy have been on the Board of Directors for Youth Sports of Hollywood for the past 6 years and has also umpired baseball and softball for many years. David and Suzy were both recognized and received the "Jerry Engelhard Achievement Award" last year for their tireless efforts and many hours of volunteering to help solidify the program. David umpired right up until the end, only missing the last week of the season due to succumbing to cancer. Suzy continues to volunteer to the program, their son continues to play in the program and their daughter continues to volunteer her time to help the program. The Shull family has been instrumental in helping Youth Sports of Hollywood in being successful throughout the years. It would be a great honor if we could rename Rotary Field 2 after David Shull to honor him and remember him for his time dedicated to Youth Sports of Hollywood.
