

**SECOND AMENDMENT TO
GENERAL PLANNING CONSULTING SERVICES AGREEMENT**

10th **THIS SECOND AMENDMENT TO AGREEMENT** (“Amendment”), dated the day of December, 2024, between:

THE CITY OF WILTON MANORS, a Florida municipal corporation,
hereinafter referred to as “CITY”,
and

CALVIN, GIORDANO & ASSOCIATES, INC. a Florida corporation,
hereinafter referred to as “CONSULTANT”.

WHEREAS, on or about December 13, 2022, the CITY entered into an agreement with CONSULTANT for general planning and consultant services (the “Original Agreement”); and

WHEREAS, on or about August 27, 2024, the CITY entered into a First Amendment to the Original Agreement; and

WHEREAS, CITY and CONSULTANT now desire to amend the Original Agreement, as amended, to extend the term of the Agreement for the first of three (3) one (1) year options and to increase the rates, subject to the terms and conditions of the Original Agreement

NOW, THEREFORE, in consideration of the mutual promises, covenants, and agreements herein contained, and other good and valuable consideration, the receipt and sufficiently of which are hereby acknowledged, the CITY and CONSULTANT agree to amend the Original Agreement as follows:

1. **RECITALS:** Each “Whereas” clause set forth above is true and correct and incorporated herein by this reference.
2. **TERMS:** Pursuant to Section 5.2 of the Original Agreement, the term of the Original Agreement shall be renewed for the first of three (3) one year (1) allowable option terms commencing December 13, 2024 and ending on December 12, 2025.
3. **RATES:** Pursuant to Section 5.2 of the Original Agreement, commencing on December 13, 2024, the rates provided for in Section 3.1 of the Original Agreement shall be amended as follows:

attached hereto.

4. **ORIGINAL AGREEMENT:** All of the terms and conditions of the Original Agreement as amended from time to time shall be binding and remain in full force and effect except as expressly amended hereinabove.

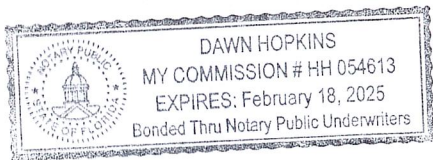
