A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH THE PETERBILT STORE SOUTH FLORIDA LLC, D/B/A THE PETERBILT STORE, FOR THE PURCHASE OF A 2024-537 PETERBILT CAB AND CHASSIS WITH HEIL PF-1000-16 YARD REAR LOADER FOR A ONE TIME PURCHASE IN AN AMOUNT UP TO \$237,645.00 BASED UPON FSA CONTRACT FSA22-VEH20.0 IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE (PIGGYBACK); AMENDING THE FISCAL YEAR 2023 OPERATING BUDGET AND CAPITAL IMPROVEMENT PLAN.

WHEREAS, the Department of Public Works is responsible for keeping the beaches clean, eliminating seaweed, removing debris, setting up and breaking down of various events, clearing City streets and property, and responding to emergency situations such as hurricanes and other natural disasters; and

WHEREAS, the Department of Public Works needs to replace a 2009 Peterbilt Rear Loader Refuse Collector-320 Cab Garbage Truck that is at the end of life with a 2024-537 Peterbilt Cab and Chassis with Heil PF-1000-16 Yard Rear Loader; and

WHEREAS, the 2024-537 Peterbilt Cab and Chassis with Heil PF-1000-16 Yard Rear Loader was competitively bid and awarded under FSA Contract FSA22-VEH20.0 Heavy Trucks & Buses; and

WHEREAS, the current term of FSA Contract FSA22-VEH20.0 is for a one-year period from October 1, 2022 to September 30, 2023; and

WHEREAS, Section 38.41(C)(5) of the Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of the Department of Public Works and the Director of Procurement and Contract Compliance recommend that the City Commission approve and authorize the execution of the attached Blanket Purchase Agreement with The Peterbilt Store South Florida LLC, d/b/a The Peterbilt Store, for the purchase of a 2024-537 Peterbilt Cab and Chassis with Heil PF-1000-16 Yard Rear Loader in an amount up to \$237,645.00; and

WHEREAS, the Fiscal Year 2023 (“FY 2023”) Operating Budget was adopted and approved by the City Commission pursuant to Resolution R-2022-283 at the second Public Budget Hearing on September 22, 2022; and

WHEREAS, the FY 2023 Capital Improvement Plan was adopted and approved by the City Commission pursuant to Resolution R-2022-284 at the second Public Budget Hearing on September 22, 2022; and

WHEREAS, it is necessary to amend the approved FY 2023 Operating Budget and Capital Improvement Plan as set forth in the attached Exhibit “1”.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing “WHEREAS” clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of the attached Blanket Purchase Agreement with The Peterbilt Store South Florida LLC, d/b/a The Peterbilt Store, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.

Section 3: That these Amendments to the FY 2023 Operating Budget and FY 2023 Capital Improvement Plan for the Fiscal Year beginning October 1, 2022, and set forth in detail in the attached Exhibit “1” are adopted and authorized as Amendments and/or Adjustments to the Operating Budget and Capital Improvement Plan of the City of Hollywood, Florida, for the Fiscal Year 2023.

Section 4: That the Department of Financial Services is authorized to establish such line-item accounts as may be necessary to properly monitor, and track appropriations.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
