RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, REPEALING RESOLUTION NO. R-2002-89 AND ESTABLISHING THAT THE DUMPSTER AND DUMPSTER ENCLOSURE REGULATIONS SET FORTH IN CHAPTER 50 OF THE CODE OF ORDINANCES WILL APPLY CITY-WIDE.

WHEREAS, Chapter 50 of the Code of Ordinances establishes the procedures and regulations for solid waste and recycling management; and

WHEREAS, on March 20, 2002, the City Commission adopted Ordinance No. O-2002-15 which established guidelines and regulations for the enclosure of dumpsters; and

WHEREAS, Section 50.02(B) sets forth that the regulations for dumpsters and dumpster enclosures shall apply to those areas designated by resolution of the City Commission; and

WHEREAS, on March 20, 2002, the City Commission passed and adopted Resolution R-2002-89 which established the areas within the City which are required to comply with the dumpster and enclosure requirements; and

WHEREAS, the problem of unsightly dumpsters without enclosures exists City-wide and the City Commission has expressed an interest in establishing guidelines and regulations for the enclosure of dumpsters which shall apply City-wide; and

WHEREAS, the City Commission desires to repeal Resolution R-2002-89 and has determined that the dumpster enclosure regulations set forth in Chapter 50 hereby applies to all areas within the City; and

WHEREAS, non-conforming properties shall be required to be brought into full compliance with the dumpster enclosure requirements set forth in Section 50.02(B) by September 1, 2018, however, those properties with dumpster enclosures pursuant to Resolution No. R-2002-89 must comply with the regulations as previously enacted by Ordinance No. O-2002-15;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That Resolution R -2002-89 is hereby repealed in its entirety.
