KBP Consulting, Inc. has prepared the following traffic analysis associated with the proposed land use plan amendment for the Emerald Hills community in Hollywood, Florida.

F. TRAFFIC CIRCULATION ANALYSIS

1) Identify the roadways impacted by the proposed amendment and indicate the number of lanes, current traffic volumes, adopted level of service, and current level of service for each roadway.

The roadway network that will be most impacted by the proposed land use plan amendment includes two (2) primary east-west roadways and four (4) primary north-south roadways. These six (6) roadways include Sheridan Street (State Road 822), Stirling Road (State Road 848), State Road 7, N. 56th Avenue, N. 46th Avenue, and N. Park Road. The project study area is presented graphically in Figure F.1 on the following page.

The number of lanes, current (2019) traffic volumes, adopted levels of service, and current operating conditions (i.e. LOS) of the roadway segments located within the study area are documented in Tables F.1.1 and F.1.2.¹ Table F.1.1 documents the existing conditions on all study roadway segments for daily conditions while Table F.1.2 presents the current conditions during the critical PM peak hour. As shown in these two tables, roadway segments on N. 56th Avenue and N Park Road are operating at level of service (LOS) “F” during the daily and PM peak hour periods. State Road 7 between Stirling Road and Griffin Road is operating at LOS “F” during the PM peak hour. All other study roadway segments are currently operating at acceptable levels of service (LOS) during the daily and PM peak hour time periods.

¹ The current traffic volumes utilized for this analysis are for the year 2019 as documented by the Broward Metropolitan Planning Organization (MPO). Year 2020 volumes have been published by the Broward MPO; however, they are viewed as less reliable because of impacts attributed to COVID-19.

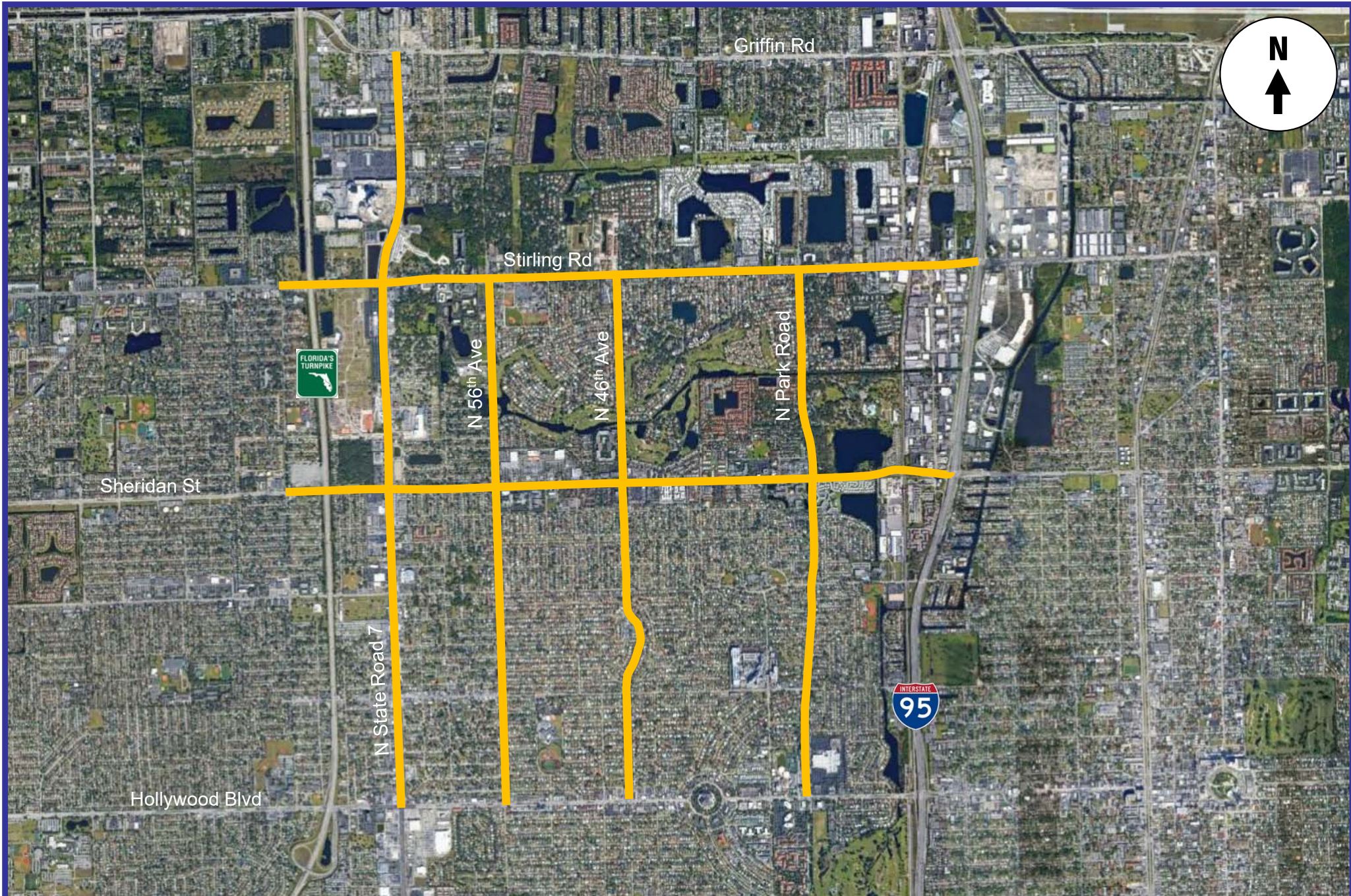

2) Identify the projected level of service for the roadways impacted by the proposed amendment for the long-range planning horizon. Please utilize average daily and p.m. peak hour traffic volumes per Broward Metropolitan Planning Organization (MPO) plans and projections.

Tables F.2.1 and F.2.2 document the projected levels of service (LOS) for the primary roadways located near the proposed amendment. The 2045 projected daily traffic volumes (AADT) and PM peak hour volumes were obtained from the Broward MPO and their most recent Level of Service Spreadsheet (Broward County Roadway Capacity and Level of Service Analysis for 2020 and 2045).

3) Planning Council staff will analyze traffic impacts resulting from the amendment. The applicant may provide a traffic impact analysis for this amendment – calculate anticipated average daily and p.m. peak hour traffic generation for the existing and proposed land use designations. If the amendment reflects a net increase in traffic generation, identify access points to/from the amendment site and provide a distribution of the additional traffic on the impacted roadway network for the long-range planning horizon.

A trip generation comparison analysis has been performed for the existing (approved) land use designation and intensity and for the proposed land use designation and intensity. The trip generation comparison analysis was based on the following assumptions:

EXISTING LAND USE AND INTENSITY

- o Commercial Recreation: 36.80 acres (golf course)

PROPOSED LAND USE AND INTENSITY

- o Single and Multifamily Residential
 - 36.8 acres of Low (5) and Low-Medium (10) residential
 - 84 low-rise units
 - 274 mid-rise units
 - 5 single-family units

The trip generation analysis was based upon information contained in the Institute of Transportation Engineer's (ITE) Trip Generation Manual (11th Edition). According to the subject ITE manual, the most appropriate land use category for the existing land use designation is Land Use #430 – Golf Course. The most appropriate land use categories for the proposed land use designations are Land Use #210 – Single-Family Detached Housing, Land Use #220 – Multifamily Housing (Low-Rise) and Land Use #221 – Multifamily Housing (Mid-Rise). The trip generation equations / rates used to determine the vehicle trips associated with this analysis are presented below.

ITE Land Use #430 – Golf Course

- Weekday: $T = 3.74 (X)$
where T = number of trips and X = number of acres
- AM Peak Hour: $T = 0.19 (X)$ (74% in / 26% out)
- PM Peak Hour: $T = 0.28 (X)$ (34% in / 66% out)

ITE Land Use #210 – Single-Family Detached Housing

- Weekday: $T = 9.43 (X)$
where T = number of trips and X = number of dwelling units
- AM Peak Hour: $T = 0.70 (X)$ (26% in / 74% out)
- PM Peak Hour: $T = 0.94 (X)$ (63% in / 37% out)

ITE Land Use #220 – Multifamily Housing (Low-Rise)

- Weekday: $T = 6.74 (X)$
where T = number of trips and X = number of dwelling units
- AM Peak Hour: $T = 0.40 (X)$ (24% in / 76% out)
- PM Peak Hour: $T = 0.51 (X)$ (63% in / 37% out)

ITE Land Use #221 – Multifamily Housing (Mid-Rise)

- Weekday: $T = 4.54 (X)$
where T = number of trips and X = number of dwelling units
- AM Peak Hour: $T = 0.37 (X)$ (23% in / 77% out)
- PM Peak Hour: $T = 0.39 (X)$ (61% in / 39% out)

The results of the trip generation comparison analysis indicate that the proposed land use plan amendment will result in 1,718 additional daily vehicle trips, 132 additional AM peak hour vehicle trips, and 145 additional PM peak hour vehicle trips. An aerial map depicting the location of each parcel and the proposed driveway locations is presented in Attachment A of this memorandum.

Further analyses have been performed by assigning the net new daily and PM peak hour vehicle trips to the roadway segments within the project study area. The assignment of traffic to the surrounding roadway network is based upon the transportation modeling effort performed by the Broward Metropolitan Planning Organization (MPO) utilizing the latest (2045) Long Range Transportation Model. The resulting traffic assignment, significance test and resulting level of service (LOS) are presented in Tables F.3.2 and F.3.3.

As shown in the preceding tables, no roadway segments are projected to be significantly impacted (i.e. greater than 3% of the adopted LOS “D” volume) and over capacity as a result of this application.

Excerpts from the Broward MPO traffic volume database are presented in Attachment B and the transportation modeling output provided by the Broward MPO is presented in Attachment C.

4) Provide any transportation studies relating to this amendment, as applicable.

A traffic impact analysis will be prepared for each of the subject sites at the time of the site plan review and submittal to the City of Hollywood. This analysis will consider operational characteristics of nearby intersections and project driveways to identify the need for intersection improvements including potential turn lanes and turn lane modifications. A preliminary review of the surrounding transportation network has been performed for the purposes of identifying potential roadway / intersection improvements intended to enhance the flow of traffic within the study area. The initial list of potential improvements includes the following:

- ***Stirling Road and N. 46th Avenue***
 - *Add a northbound left-turn lane on N. 46th Avenue*
 - *Extend the existing northbound left-turn lane on N. 46th Avenue*
- ***N. 46th Avenue and Casper Court***
 - *Add a northbound left-turn lane on N. 46th Avenue*
 - *Add a southbound right-turn lane on N. 46th Avenue*
 - *Relocate golf cart crossing to the south to be controlled by the traffic signal*
 - *Add a westbound right-turn lane on Casper Court*
- ***Sheridan Street and N. 46th Avenue***
 - *Extend the existing southbound left-turn lane on N. 46th Avenue*

These improvements as well as access related improvements to each of the subject parcels are presented graphically in Attachment D.

G. MASS TRANSIT ANALYSIS

1) Identify the mass transit modes, existing and planned mass transit routes and schedule service (headway) serving the amendment area within one-quarter of a mile.

Within the general area Broward County Transit (BCT) operates a fixed-route bus system. More specifically, the amendment area is served by Route 12 and Route 15. These routes are accessible from the subject parcels through bus stops located along Sheridan Street and N. 56th Avenue. BCT Route 12 travels between State Road A1A and the West Regional Terminal at University Drive and Broward Boulevard in Plantation. And BCT Route 15 serves the communities between the I-95 and State Road 7 corridors between West Park to the south and the Tri-Rail station at Griffin Road and I-95 to the north. Table G.1 below summarizes the service times and headways for these routes and route information published by BCT is presented in Attachment E.

2) Describe how the proposed amendment furthers or supports mass transit use.

The amendment area is generally bounded by Sheridan Street to the south, Stirling Road to the north, N. 40th Avenue to the east and N. 56th Avenue to the west. The Sheridan Street corridor is served by Broward County Transit (BCT) Route 12 and the N. 56th Avenue corridor is served by Route 15. The recreational and residential development will have increased employment opportunities and a greater residential density that is typically supportive of transit usage. Each site will be designed in a manner that provides safe movement of pedestrians within the site and will provide connectivity to existing sidewalks leading to the existing bus stops. Therefore, the proposed land use change will be supportive of the transit service within the overall region.

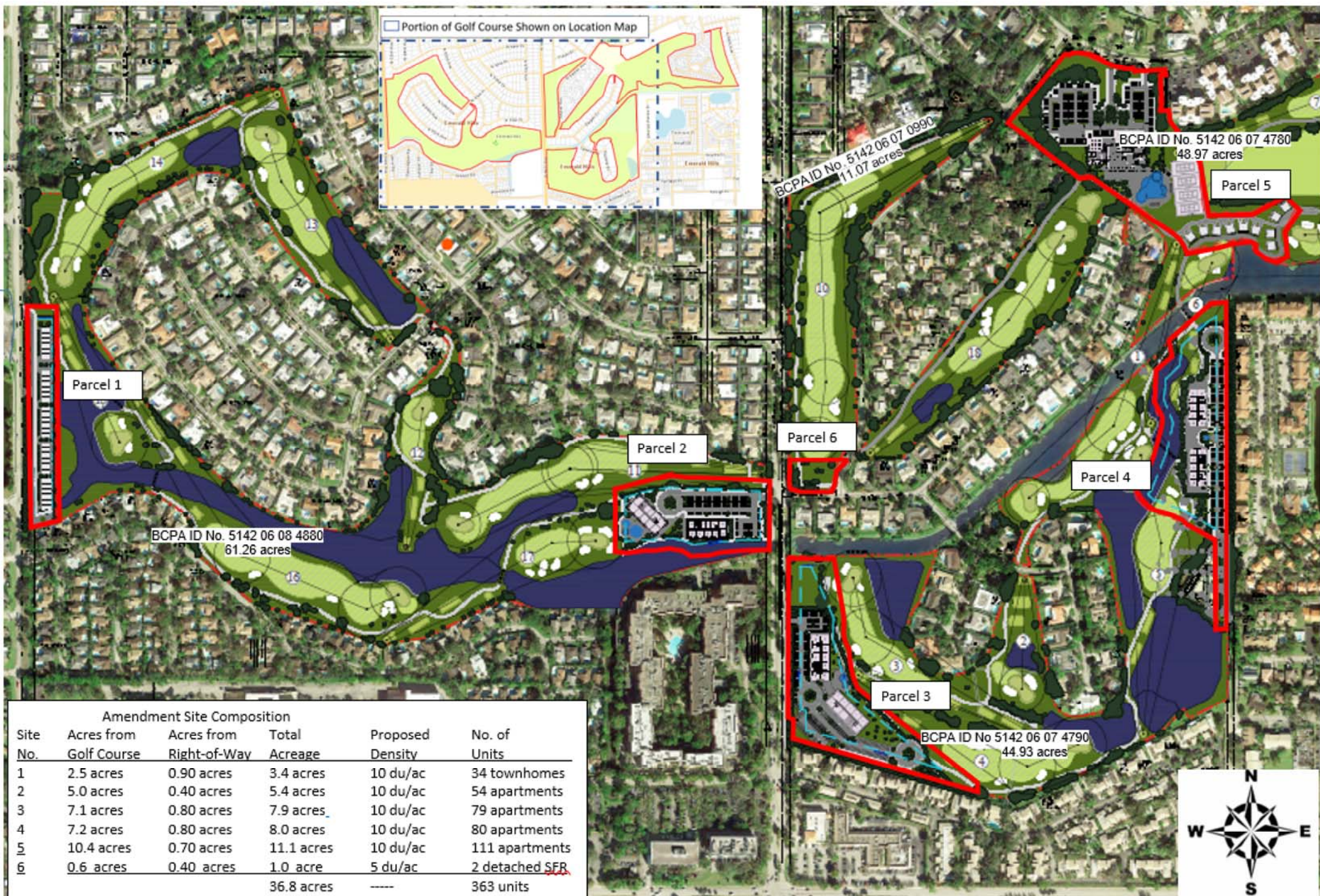

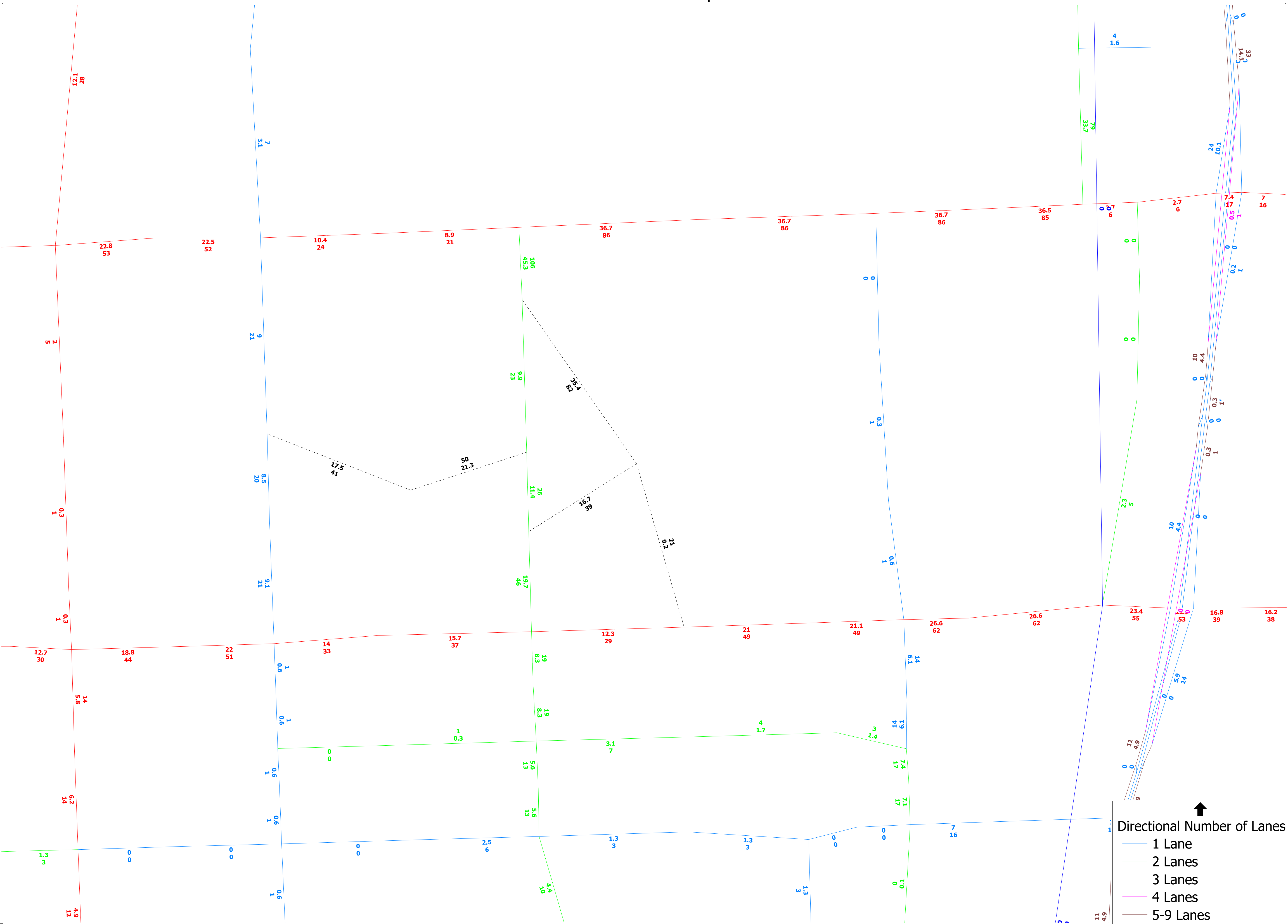

Traffic Modeling Output from the Broward MPO

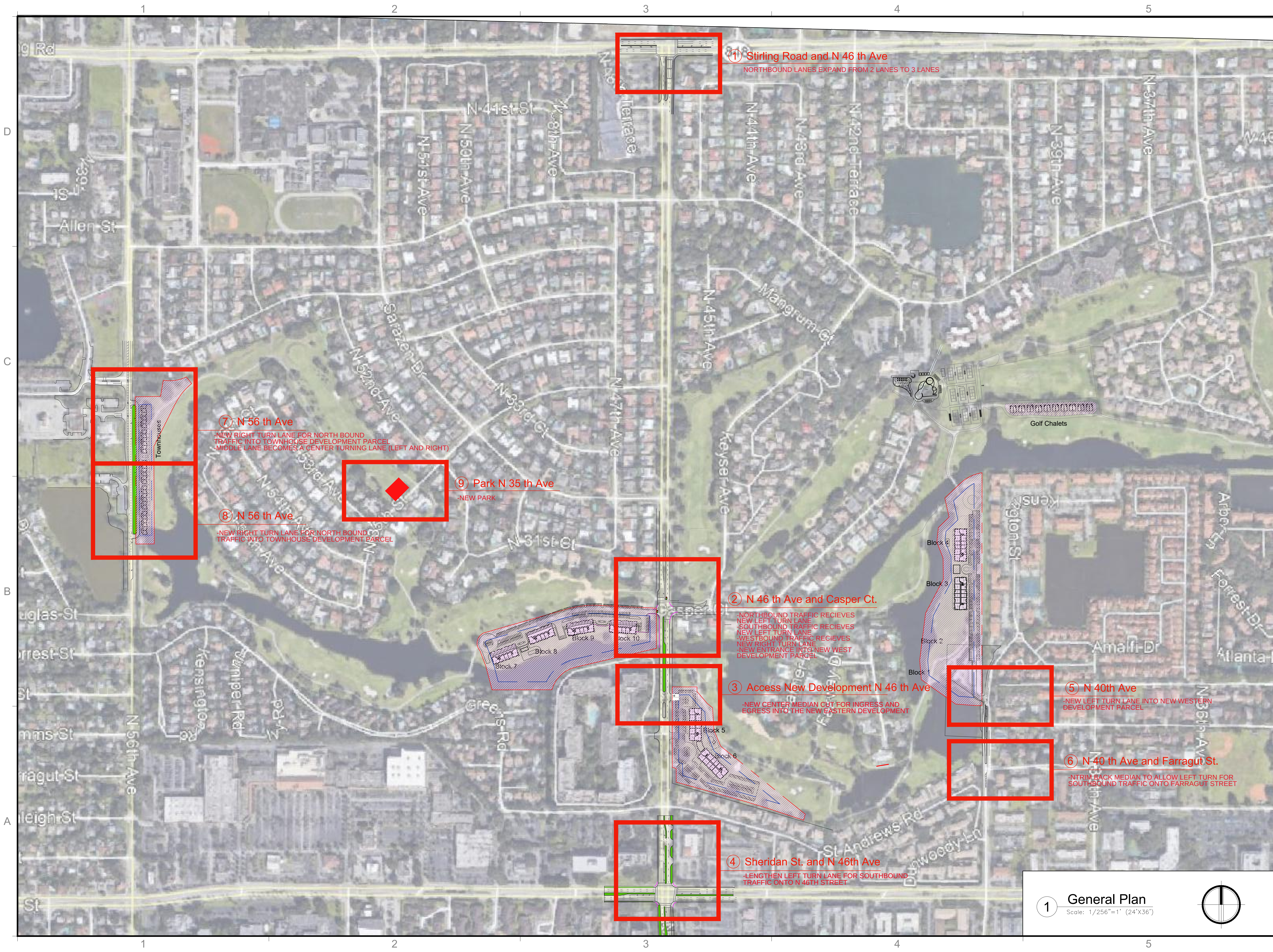

TRANSFER POLICY - EFFECTIVE 7/10/11

TRANSFERS BETWEEN REGULAR BCT BUS SERVICE AND BCT EXPRESS BUS SERVICE

Passengers using any BCT bus pass and transferring from a regular BCT route, to an Express bus route, must pay a \$1.00 upgrade fee. Passengers with a Premium bus pass do not have to pay the \$1.00 upgrade fee.

Passengers paying with cash, on a regular BCT bus route, will not be able to transfer to an Express bus route without paying the full premium fare when boarding the Express bus.

Passengers using an All-Day bus pass will be required to pay the \$1.00 upgrade fee when boarding Express buses.

PREMIUM BUS PASS CUSTOMERS

The BCT 31-Day Premium Bus Pass is acceptable on all BCT regular bus routes.

TRANSFERS FROM BCT TO OTHER SOUTH FLORIDA TRANSIT SYSTEMS

When boarding a BCT bus, passenger pays the appropriate BCT fare and may request a transfer from the bus operator if transferring to Miami-Dade Transit (MDT), Palm Tran or Tri-Rail.

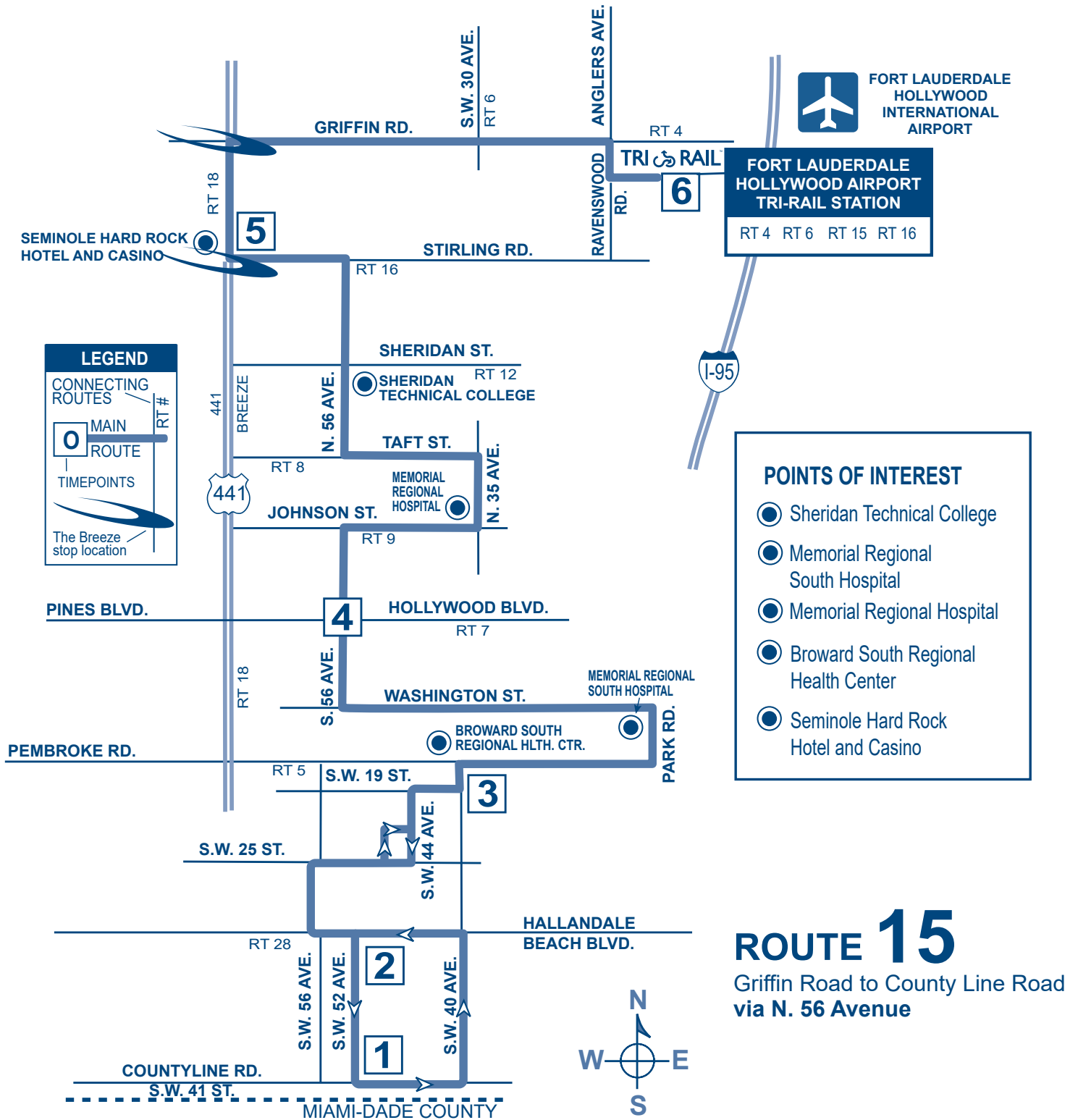

TRANSFER POLICY - EFFECTIVE 7/10/11

TRANSFERS BETWEEN REGULAR BCT BUS SERVICE AND BCT EXPRESS BUS SERVICE

Passengers using any BCT bus pass and transferring from a regular BCT route, to an Express bus route, must pay a \$1.00 upgrade fee. Passengers with a Premium bus pass do not have to pay the \$1.00 upgrade fee.

Passengers paying with cash, on a regular BCT bus route, will not be able to transfer to an Express bus route without paying the full premium fare when boarding the Express bus.

Passengers using an All-Day bus pass will be required to pay the \$1.00 upgrade fee when boarding Express buses.

PREMIUM BUS PASS CUSTOMERS

The BCT 31-Day Premium Bus Pass is acceptable on all BCT regular bus routes.

TRANSFERS FROM BCT TO OTHER SOUTH FLORIDA TRANSIT SYSTEMS

When boarding a BCT bus, passenger pays the appropriate BCT fare and may request a transfer from the bus operator if transferring to Miami-Dade Transit (MDT), Palm Tran or Tri-Rail.

TRANSFERS TO BCT FROM OTHER SOUTH FLORIDA TRANSIT SYSTEMS

When transferring from MDT, Palm Tran and Tri-Rail to BCT regular fixed-route bus service, passenger pays \$.50 with a transfer issued by MDT or Palm Tran and proof of fare payment such as Easy Card and receipt issued by Tri-Rail. Tri-Rail passengers boarding BCT at any locations other than at a Tri-Rail station will be required to pay the full fare.

TRANSFERS BETWEEN OTHER SOUTH FLORIDA TRANSIT SYSTEMS AND PREMIUM EXPRESS BUS SERVICE

Transfers to MDT or Tri-Rail from Premium Express Service, a transfer is issued and passenger must pay appropriate MDT or Tri-Rail fare.

Transfer from MDT or Tri-Rail to Premium Express Service, a \$.50 transfer fee is required with the appropriate transfer from MDT or Tri-Rail.

The Premium Express Service does not connect with Palm Tran.

The Easy Card issued by MDT and Tri-Rail is not accepted as payment on any BCT bus.
