I. STATEMENT OF THE AGENCY'S PURPOSE

Hispanic Unity of Florida (HUF) was founded in 1982 by community leaders to guide newcomers to the U.S. on their journey to their American dream and to ease the acculturation process. Today, HUF is Broward County's largest 501(c) (3) dedicated to the immigrant population. With 12 programs and more than 30 services offered in four (4) languages, the agency serves South Florida's diverse community. Since its inception, HUF has served more than 520,000 individuals.

For the past several years, HUF's comprehensive approach to advance and accelerate the pace of social and economic stability is a family-centered two generation (2Gen) approach that operates through a racial equity lens. HUF's integrated services provide a seamless framework of economic stability that includes immediate assistance as well as long-term solutions. which builds family well-being by intentionally and simultaneously working with children and their parents together. The 2Gen approach centers on the whole family, simultaneously tracking outcomes and creating a legacy of educational success and economic prosperity that passes from one generation to the next.

HUF provides the following programs and services:

Education

- Unity 4Kids (U4K) Early Learning Center: 5-Star Rated, Nationally-Accredited Licensed Pre-K & VPK for 3- to 5-Year-olds.
- Unity 4Teens (U4T) Program: Year-round After-School & Summer-School Program for Youth ages 11- to 18.
- English for Speakers of Other Languages (ESOL) (in partnership with Broward Public Schools).
- Family Strengthening Program: Research-based parent-education program that teaches parents the importance of engaging in nurturing behavior promoting healthy physical and emotional development in children.

Economic Development

- Center for Working Families (CWF) Program: Comprehensive one-stop shop that consists of public benefits assistance, employment services and money management assistance.

- Financial Capability & Wealth Building services provide housing counseling that helps clients find, finance, maintain, rent, or own a home. The program also addresses homelessness through counseling and assists homeowners in need of foreclosure assistance.
- Financial Coaching services provide step by step directions to support clients' recovery from financial hardship.
- First-time Home Buyers services include housing counseling to help assess options for trouble paying mortgage loan, and a plan to get them the help they need with their mortgage.
- Emerging Entrepreneurs (EE): Workshops in Spanish for Existing & Emerging Small Business Owners.
- Income Support: Health and Public Benefits
 - Broward Tax Pro (also known as Volunteer Income Tax Assistance (VITA) is a free tax preparation service for individuals or families with an annual income of \$66,000 or less.
 - Te Ayudo offers health insurance application and navigation assistance.
 - Comprando Rico y Sano offers SNAP enrollment application assistance and nutrition education.
 - Health Literacy Outreach and Education service increases awareness in public health efforts to prevent the spread and lessen the impact of infectious diseases.
 - HEAL Program is a referral program that promotes and facilitates access to health and mental health literacy.

HUF's U4T afterschool and summer program at Hollywood Hills High School offers formalized education that aims to help students identify and foster talent and affinity for Science, Technology, Engineering, Arts, and Mathematics (STEAM). HUF first began incorporating STEAM in its U4T programming in 2013 and expanded to Hollywood Hills in 2021. Students receive lessons that stimulate creativity, design, critical thinking, technology, literacy, collaboration, mathematical skills, scientific investigation, and problem solving. The program is open to all four grades but targets freshmen and sophomores, as studies have shown that crucial academic pathways and career-affecting decisions begin in the first two years of high school. U4T administers STEAM in a holistic manner to effectively lay a foundation for academic success, post-secondary education, and career aspiration. Examples of STEAM activities include creating a solar-powered cart; setting up a botany lab and irrigation system; planting a community garden; creating musical instruments; and learning about computer coding. The structure and delivery of lessons teach students the appeal and broad variety of careers in the STEAM field as well as leads students to develop a STEAM mindset — one that encourages problem solving, creativity, curiosity and innovation, all skills that contribute to future academic and social success. Additionally, HUF utilizes Junior Achievement's 22Career Success and Personal Finance curricula which helps students recognize the preparation, education requirements and training necessary to enter STEAM-related careers.

IV. PROGRAM/PROJECT NEEDS AND OBJECTIVES:

U4T's STEAM program provides access to quality STEAM education and career exploration for participating Hollywood Hills HS students in an afterschool setting and during the summer. Studies show that only one (1) in five (5) students felt their K-12 education adequately prepared them for college STEAM courses. Further, data from the Department of Education's Office for Civil Rights showed African American and Latino students are much less likely to have access to Advanced Placement courses in STEAM fields - which impacts their acceptance to certain colleges and access to a great number of scholarships.

It is no secret that innovation drives the 21st century economy and that it is essential young adults are exposed to opportunities in STEAM - especially in communities that are underserved. According to the Greater Ft. Lauderdale Alliance through the research completed by Broward College and the Alliance's Prosperity Broward Initiative, occupations in Broward County with high earnings are related to computer and mathematical fields, along with architecture and engineering.

Students spend 80% of their time outside of the classroom and opportunities lie in all aspects of their education, including enrichment programs that take place during the afterschool hours and the summer. U4T provides an ideal opportunity to expose and engage Hollywood youth in high-quality STEAM programming and help them to develop true interests in STEAM.

V. ANTICIPATED OUTCOMES:

U4T’s hands-on, project-based, STEAM learning activities engage youth and promote higher-level learning skills. Ongoing activities enhance students’ academic skills while exposing them to the wonders of STEAM education. U4T’s holistic STEAM approach stimulates students’ skills in creativity, design, critical thinking, technology, literacy, collaboration, mathematical skills, scientific investigation, and problem solving, all in the context of career aspiration. Service-learning activities prepare youth to enter STEAM fields by promoting their civic engagement, creating positive and safe environments that reduce risky behaviors and help them develop social and behavioral skills. Measurable outcomes from program participation include students’ increased knowledge of STEAM careers and the pathways needed to achieve them and academic improvement in Reading, Math and Science. Most importantly, students who participate in U4T STEAM programs receive more than a quality education, they gain tools and strategies to break the cycle of poverty and pursue social and economic mobility.

HUF began offering STEAM programming to U4T students at Hollywood Hills High school in February 2021. The City of Hollywood's General Agency Fund support for this program commenced in FY 2022. Since the start of the 22-23 school year, the program has directly served 31 students at Hollywood Hills High School. To date, programmatic focus has been placed on learning math skills. During the first three months, U4T students were engaged in Financial Literacy training where they developed mathematics training by taking part in activities that included developing and managing a financial plan, creating a budget and participating in a real life family scenario that exposed them to the skills needed to manage their income.

In subsequent months, U4T students will engage in other STEAM focused activities that will include robotics and computer programming and coding.

COMMUNITY COLLABORATIONS AND PARTNERS:

With support from the Children's Services Council of Broward County, Hollywood Hills High School is one of eight (8) Title I schools where HUF provides afterschool & summer programming. HUF started providing U4T programming at Hollywood Hills in the summer of 2020. Prior to that, HUF and Hollywood Hills collaborated on a one-year project where students created "Guide to Goals", a website helping students recognize and understand the steps required for different career goals.

Additional partners include employers & educational institutions in STEAM-related fields, such as the Marine Institute Cares Foundation and Nova Southeastern University. HUF also utilizes Junior Achievement's Career Success and Personal Finance curricula which helps students to recognize the preparation, education requirements and training necessary to enter STEAM-related career fields.
