A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED RIGHT-OF-WAY OCCUPANCY PERMIT BETWEEN THE CITY OF HOLLYWOOD AND 2008 HOLLYWOOD, LLC, FOR A SIGN STRUCTURE PROJECTING WITHIN THE HOLLYWOOD BOULEVARD RIGHT OF WAY AT 2008 HOLLYWOOD BOULEVARD.

WHEREAS, 2008 Hollywood, LLC, is the owner of property located at 2008 Hollywood Boulevard and has requested approval from the City to have a Cinema Marquee sign across the frontage of the Cinema Paradiso in Downtown Hollywood, located at 2008 Hollywood Boulevard; and

WHEREAS, on September 23, 2014, the owner filed an Application with the Department of Planning for consideration of a variance for a Marquee Sign by the Historic Preservation Board; and

WHEREAS, after a duly noticed hearing, the Historic Preservation Board passed and adopted Resolution No. 14-V-80 which approved the sign variance with conditions; and

WHEREAS, the sign projection will not encroach more than four (4) feet into the public right-of-way, and a minimum eight (8) foot vertical clearance over the sidewalk would be maintained to accommodate pedestrian and downtown activities; and

WHEREAS, in consideration of the request, the owner will execute the attached Right-of-way Occupancy Permit;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached Right of Way Occupancy Permit, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legality by the City Attorney.
