2. Product/Service being requested (be specific). Vertical Solids Handling C5445 Pump, 10" Tangential Volute, Std 2 Vane Impeller, T60 Frame to Replace Fairbanks S/N: K4B1-061736.

3. Detailed description of the product/service's function and purpose. The C5445 Pumps provides pre-treated effluent water to be filtered through sand filters and subsequently reused internally through multiple treatment process areas at the Southern Regional Wastewater Treatment Plant ("SRWWTP"). These pumps are the main link in the production of reused water. After exiting the sand filters, this water is handled by the on-site reuse Pump Station (Non-Potable Pump Station). The non-potable water is for internal use only throughout the WWTP for seal water systems, cleaning, chlorine gas dosing, the belt presses, Pumps, clarifiers. Each component is important within WWTP for the Protection of Public Health and Safety.

4. Please explain in detail why this vendor is the sole source supplier for the required product/service. Be sure to explain the necessary features this vendor provides which are not available from any other vendor. Fairbanks Nijhuis pumps (formally Fairbanks Morse). Barney's Pumps, Inc. is the sole distributor serving the municipal market in the state of Florida (exclusive of the panhandle counties west of the Apalachicola River). Barney's

Pumps, Inc. is the sole facility authorized to provide warranty and non-warranty service and repair for these products.

5. Please explain in detail what process the Department/Office took to verify that there are no other vendors or products/services available to perform the required function. There are no other products available to us, due to the installed equipment is Fairbanks Morse, and Barney's Pumps, Inc. is the exclusive manufacturer representative for this area. Sole Source letter is attached.
