A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE PURCHASE ORDERS TO STINGRAY CHEVROLET, DUVAL FORD, LLC., ALAN JAY CHEVROLET, INC., RECHTIEN INTERNATIONAL TRUCK, INC., AND ALAN JAY TOYOTA FOR THE PURCHASE OF 36 VEHICLES FOR A TOTAL AMOUNT OF \$1,616,695.50.

WHEREAS, the Department of Public Works, Fleet Management Division, on behalf of various City departments, requires the purchase of 36 new vehicles to replace a portion of those vehicles that have reached or surpassed their life expectancy and road worthiness by age, mileage and wear, and can no longer be relied upon to perform at required operational levels; and

WHEREAS, the 36 new vehicles requested are as follows:

- (1) Police Department: (20) 2019 Chevrolet Tahoe 1500 RWD Police Patrol Vehicles from Stingray Chevrolet, costing \$774,120.00;
- (2) Department of Public Works, Facility Maintenance Division: One 2019 Ford F-250 Utility Body Truck, 4x2 from Duval Ford, LLC., costing \$32,842.000;
- (3) Department of Information Technology: One 2019 Ford Escape SUV from Duval Ford, LLC., costing \$20,525.00;
- (4) Department of Parks, Recreation & Cultural Arts and Department of Public Works, Streets Maintenance Division: Four 2019 Chevrolet Silverado 1500 Trucks from Alan Jay Chevrolet, Inc., costing \$106,309.00;
- (5) Department of Parks, Recreation & Cultural Arts: Four 2019 Chevrolet Express 2500 LS 12-Passenger Vans from Alan Jay Chevrolet, costing \$110,717.00;
- (6) Department of Public Works, Beach Maintenance Division: One 2019 Chevrolet Silverado 1500 Truck from Alan Jay Chevrolet, costing \$31,137.25;
- (7) Department of Public Works, Urban Forestry Division: One 2019 Ford F-550 Cab & Chassis with 2-3 Yard Dump Body Truck from Duval Ford, LLC., costing \$53,858.00;
- (8) Department of Public Works, Urban Forestry Division: One 2019 International Durastar MV (4x2) with Altect AT40G Telescoping/Articulating Aerial Device (Bucket Truck) from Reichtien International Truck, Inc., costing \$159,552.00;
- (9) Department of Public Works, Urban Forestry Division: Two 2019 International MV w/ Petersen TL-3 Lightning Loaders w/1824 Dump Body (Combo Cranes) from Reichtien International Truck, Inc., costing \$306,852.00; and
- (10) Parking Division: One 2019 Toyota Prius II Hybrid Sedan from Alan Jay Toyota, costing \$26,792.25; and

WHEREAS, the requested vehicles were competitively bid through the Florida Sheriff's Association pursuant to Bid Number FSA18-VEL26.0 for a term effective October 1, 2018 through September 30, 2019, and pursuant to Bid Number FSA18-VEH16.0 for the use and reliance of government entities within the State of Florida; and

WHEREAS, award was made to Stingray Chevrolet, Duval Ford, LLC., Alan Jay Chevrolet, Inc., Recthien International Truck, Inc., and Alan Jay Toyota as the lowest and best responsive bidders by specification, manufacturer and by zone; and

WHEREAS, Stingray Chevrolet, Duval Ford, LLC., Alan Jay Chevrolet, Inc., Recthien International Truck, Inc., and Alan Jay Toyota have agreed to provide the requested vehicles as listed in the Florida Sheriff's Bid Numbers FSA18-VEL26.0 and FSA18-VEH16.0 to the City under similar pricing, terms and conditions; and

WHEREAS, the City's Purchasing Ordinance, Section 38.40(C)(5) allows the Director to procure, without following formal procedures, all goods and services which are subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided that the goods and services are: (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, the Director of Public Works and the Director of Procurement and Contract Compliance recommend that the City Commission approve and authorize the issuance of Purchase Orders to: (1) Stingray Chevrolet for 20 vehicles for the Police Department, in the amount of \$774,120.00; (2) Duval Ford, LLC., for three vehicles for the Departments of Information Technologies and Department of Public Works in the amount of \$107,225.00; (3) Alan Jay Chevrolet for nine vehicles for the Departments of Parks, Recreation, and Cultural Arts, and Department of Public Works in the amount of \$242,154.25; (4) Recthien International Truck, Inc., for three vehicles for the Department of Public Works in the amount of \$466,404.00; and (5) Alan Jay Toyota for one vehicle for the Parking Division in the amount of \$26,792.25; and

WHEREAS, funding for the attached Purchase Orders has been appropriated and exists in account numbers, 557.519901.51900.564520.000117.000.000, 557.519901.51900.564520.000118.000.000, 557.519901.51900.564520.000120.000.000, and 557.519901.51900.564520.000233.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of Purchase Orders to Stingray Chevrolet, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That it approves and authorizes the issuance, by the appropriate City Officials of a Purchase Order to Duval Ford, LLC., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4: That it approves and authorizes the issuance, by the appropriate City Officials of Purchase Orders to Alan Jay Chevrolet, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 5: That it approves and authorizes the issuance, by the appropriate City Officials of Purchase Orders to Rechtiem International Truck, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 6: That it approves and authorizes the issuance, by the appropriate City Officials of Purchase Orders to Alan Jay Toyota, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 7: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
