A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO IMPLEMENT A SETTLEMENT WITH ROBERT LAWRENCE CLEAVER II IN THE AMOUNT OF \$76,037.00.

WHEREAS, on July 28, 2021, Robert Lawrence Cleaver II (“Claimant”) filed a civil action against the City seeking damages arising out of an automobile accident involving a City-owned vehicle that occurred on November 4, 2018 (Broward County Circuit Court Case Number CACE-21-014926); and

WHEREAS, Claimant alleges that he was injured as a result of the automobile collision; and

WHEREAS, the City Attorney and Claimant’s attorney have negotiated a settlement in the amount of \$76,037.00; and

WHEREAS, if this settlement is approved by the City Commission, the monies will be paid from the City’s self-insurance fund; and

WHEREAS, by entering into this settlement, the City does not in any manner admit liability for the incident, but rather, settlement is a business decision to avoid the risk of a jury trial, and because of this, the City Attorney recommends that the City Commission approve the negotiated settlement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That the settlement is approved, payable from the City’s self-insurance fund.

Section 3: That appropriate City officials are authorized to take all necessary steps to implement the settlement.
