A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CHANGING THE REGULAR COMMISSION MEETINGS SCHEDULED IN JULY 2016, SCHEDULING A REGULAR COMMISSION MEETING ON AUGUST 31, 2016, CHANGING THE REGULAR COMMISSION MEETINGS SCHEDULED IN NOVEMBER 2016 AND DECEMBER 2016, AND CANCELLING THE JANUARY 4, 2017 COMMISSION MEETING.

WHEREAS, Section 2.04 of the Charter of the City of Hollywood provides, in relevant part, that the City Commission shall meet regularly not less than 20 times during the calendar year, at such times and places as shall be specified by Resolution; and

WHEREAS, pursuant to a series of resolutions, the City Commission has adopted its regular meeting schedule as the first and third Wednesdays of each month starting at 1:00 PM, except during the month of August; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, July 6, 2016 meeting to Wednesday, July 13, 2016 with citizens' comments at 5:00 PM; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, July 20, 2016 meeting to Wednesday, August 31, 2016 with citizens' comments at 5:00 PM; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, November 16, 2016 meeting to Tuesday, November 22, 2016 starting at 9:00 AM, with citizens' comments at 5:00 PM; and

WHEREAS, the November date change is due to the National League of Cities Conference and the City not being able to receive the November 8, 2016 certified election results from the Broward County Supervisor of Elections until Friday, November 18, 2016; and

WHEREAS, the rescheduled date will allow the newly elected officials to be sworn into office; and

WHEREAS, the City Commission desires to change the regularly scheduled Wednesday, December 7, 2016 meeting to Wednesday, December 14, 2016 with citizens' comments at 5:00 PM; and

WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, December 21, 2016 meeting; and

WHEREAS, the City Commission desires to cancel the regularly scheduled Wednesday, January 4, 2017 meeting;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the regular meeting of the Hollywood City Commission scheduled on July 6, 2016, shall be rescheduled to Wednesday, July 13, 2016, at 1:00 PM, with citizen's comments at 5:00 PM, in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard.

Section 2: That the regular meeting of the Hollywood City Commission scheduled on July 20, 2016, shall be rescheduled to Wednesday, August 31, 2016, at 1:00 PM, with citizens' comments at 5:00 PM, in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard.

Section 3: That the regular meeting of the Hollywood City Commission scheduled on November 16, 2016, shall be rescheduled to Tuesday, November 22, 2016, at 9:00 AM, with citizens' comments at 5:00 PM, in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard.

Section 4: That the regular meeting of the Hollywood City Commission scheduled on December 7, 2016, shall be rescheduled to Wednesday, December 14, 2016, at 1:00 PM, with citizen's comments at 5:00 PM, in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard.

Section 5: That the regular meeting of the Hollywood City Commission scheduled for December 21, 2016, shall be cancelled.

Section 6: That the regular meeting of the Hollywood City Commission during January 4, 2017, shall be cancelled.

Section 7: Thereafter, regular meetings of the City Commission shall, unless otherwise provided by Resolution, be held on the first and third Wednesdays of each month other than August.

Section 8: That this resolution shall be in full force and effect immediately upon its passage and adoption.
