A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING A ONE YEAR RENEWAL OF BLANKET PURCHASE AGREEMENT NO. PA600277 WITH WEEKLEY ASPHALT PAVING, INC. FOR ROADWAY, DRAINAGE, AND MISCELLANEOUS CONSTRUCTION.

WHEREAS, on October 21, 2020, the City Commission passed and adopted Resolution No. R-2020-277 approving and authorizing the execution of a Blanket Purchase Agreement (PA600277) in an amount not to exceed \$8,816,335.00 with Weekley Asphalt Paving, Inc. ("Weekley") for roadway, drainage and miscellaneous construction with a contract term from November 25, 2019 through November 24, 2021, with an option to renew the contract for an additional one-year period; and

WHEREAS, Broward County executed the option to renew the "Open-End Contract" for the additional one-year period, which extended the Contract end date to November 24, 2022; and

WHEREAS, the Department of Development Services, Engineering, Transportation and Mobility Division ("Division"), desires to renew the attached Blanket Purchase Agreement (PA600277) in accordance with the contract for the additional one-year period, which would extend the Blanket Purchase Agreement end date to November 24, 2022; and

WHEREAS, Section 38.49(C)(1) of the Procurement Code states that when a contract entered into by the City pursuant to City Commission approval provides for one or more renewals by affirmative action of the City and the estimated annual cost of a renewal exceeds \$250,000.00, only the City Commission is authorized to approve such renewals, which includes this desired renewal due to estimated annual costs expected to exceed \$250,000.00 during the one-year renewal period; and

WHEREAS, the Director of Development Services, the City Engineer and the Chief Procurement Officer recommend that the City Commission approve and authorize the one-year renewal of the attached Blanket Purchase Agreement (PA600277) with Weekley that was previously approved in Resolution No. R-2020-277; and

WHEREAS, funding for the renewal of the attached Blanket Purchase Agreement (PA600277) will be available in account numbers 336.149901.54100.563010.001256.000.000, 336.149901.54100.563010.001240.000.000, 334.149901.54100.563030.000070.000.000, 334.149901.51900.563010.001292.000.000; 333.309901.57200.563010.001201.000.000, 334.309901.57200.564530.001275.000.000, 302.160502.54100.563030.001530.000.000, 302.160502.54100.563030.001535.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the renewal of the Blanket Purchase Agreement (PA600277), under the same terms and conditions, with Weekley Asphalt Paving, Inc., together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
