A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD. AUTHORIZING FLORIDA. APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH NATIONAL COLLISION AND TRUCK CENTER, 3 BUDDIES PAINT & BODY D/B/A HOLLYWOOD COLLISION CENTER, GARY'S AUTO BODY AND PLATINUM COLLISION. COMPREHENSIVE AUTOBODY REPAIR SERVICES IN AN AMOUNT UP TO \$ 1,200,000.00 OVER A THREE-YEAR PERIOD WITH AN OPTION TO RENEW FOR TWO ADDITIONAL ONE-YEAR PERIODS. (BID)

WHEREAS, the Police Department and Department of Public Works need comprehensive autobody services for a range of the City's fleet to supplement current contracted services for vehicle repair; and

WHEREAS, the solicitation for vehicle repair services was advertised before the implementation of the current contracted services; and

WHEREAS, the Police Department and Department of Public Works recognize the solicitation's usefulness to provide comprehensive autobody services in unique circumstances and for specialized vehicles that fall outside of the scope of contracted services; and

WHEREAS, Section 38.43 of the Procurement Code states that when the estimated annual cost of goods, supplies, materials, equipment, or services exceeds \$50,000.00, a formal solicitation process shall be completed that may result in a written contract(s) and/or purchase order(s) after due public notice inviting bids or proposals; and

WHEREAS, on March 5, 2025, Invitation For Bid Number IFB-290-25-SA ("IFB") was electronically advertised on OpenGov.com to solicit the desired comprehensive automobile repair services in accordance with Section 38.43(A) of the Procurement Code; and

WHEREAS, the IFB resulted in proposals from the following nine firms by the response due date:

- 2. California Custom Sport Trucks
- 3. Gary's Auto Body West Inc
- 4. Grieco Ford Ft. Lauderdale
- 5. IELM LLC
- 6. Mobile Techs LLC

- 7. National Collision and Truck Center
- 8. Platinum Collision Inc
- 9. Sawgrass Ford Collision Center ; and

WHEREAS, based on the vendors' responsiveness and ability to provide services for all bid line items, the following vendors were ranked in three categories, with the lowest total cost being the highest ranked as follows:

Group 1: Light Duty Vehicles (up to 10,000 lbs)

- 1. National Collision and Truck Center
- 2. Gary's Auto Body West
- 3. 3 Buddies Paint & Body d.b.a. Hollywood Collision Center
- 4. Platinum Collision, Inc.
- Group 2: Medium Duty Vehicles (10,001 lbs to 26,000 lbs)
 - 1. 3 Buddies Paint & Body d.b.a. Hollywood Collision Center
 - 2. Gary's Auto Body West
 - 3. Platinum Collision, Inc.
 - 4. National Collision and Truck Center

Group 3: Heavy Duty Vehicles (26,001 lbs and over)

- 1. 3 Buddies Paint & Body d.b.a. Hollywood Collision Center
- 2. Platinum Collision, Inc.
- 3. Gary's Auto Body West
- 4. National Collision and Truck Center ; and

WHEREAS, the Police Department desires to assign Primary, Secondary, Tertiary, and Quaternary designations in corresponding order to the four highest-ranked vendors in each category to ensure continuity of services and to meet service demands; and

WHEREAS, the Police Chief and Chief Procurement Officer recommend that the City Commission authorize the execution of Blanket Purchase Agreements with the four highest ranked vendors in each category for a combined amount up to \$1,200,000.00, and a term of three years with an option to renew for two additional one-year periods to provide comprehensive autobody repair services; and

WHEREAS, a portion of the funding for the Blanket Purchase Agreement is available in account numbers 001.204105.52100.546420.000000.000.000 and 557.510101.51900.546320.000000.000, and will be requested in subsequent fiscal years' operating budgets subject to approval and adoption by the City Commission; and

WHEREAS, additional funding will be identified in various departmental budgets as needed.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves the ranking of the firms as follows:

Group 1: Light Duty Vehicles (up to 10,000 lbs)

- 1. National Collision and Truck Center
- 2. Gary's Auto Body West
- 3. 3 Buddies Paint & Body d/b/a Hollywood Collision Center
- 4. Platinum Collision, Inc.

Group 2: Medium Duty Vehicles (10,001 lbs to 26,000 lbs)

- 1. 3 Buddies Paint & Body d/b/a Hollywood Collision Center
- 2. Gary's Auto Body West
- 3. Platinum Collision, Inc.
- 4. National Collision and Truck Center

Group 3: Heavy Duty Vehicles (26,001 lbs and over)

- 1. 3 Buddies Paint & Body d/b/a Hollywood Collision Center
- 2. Platinum Collision, Inc.
- 3. Gary's Auto Body West
- 4. National Collision and Truck Center

Section 3: That it authorizes the appropriate City officials to execute Blanket Purchase Agreements embodying the terms and conditions approved by the City Commission this date, with National Collision And Truck Center, 3 Buddies Paint & Body d/b/a Hollywood Collision Center, Gary's Auto Body West, and Platinum Collision, Inc., in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 4</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
