**Proposed Legislation:**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED AUTHORIZATION TO PROCEED FOR WORK ORDER NO. ANA 15-01 BETWEEN ATKINS NORTH AMERICA, INC. AND THE CITY OF HOLLYWOOD TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR THE WATER MAIN REPLACEMENT PROGRAM FROM PEMBROKE ROAD TO HOLLYWOOD BOULEVARD AND BETWEEN SOUTH FEDERAL HIGHWAY AND SOUTH 21ST AVENUE, AS IDENTIFIED IN THE 2007 WATER SYSTEM MASTER PLAN, IN THE LUMP SUM AMOUNT OF \$587,453.00 AND TO APPROVE FUNDING FOR THE FY 2015 WATER MAIN PROJECT AS DETAILED IN THE ATTACHED EXHIBIT A (PROJECT NO. 14-5123).

**Explanation:**

The 2007 Wastewater Master Plan included the need to replace aging water distribution system pipes. This project is currently addressing Pembroke Road to Hollywood Boulevard and between South Federal Highway and South 21st Avenue.

The City of Hollywood and Atkins North America, Inc. have a Professional Services Agreement for General Engineering Consulting Services and this agreement was

approved by the City Commission via Resolution No. R-2003-003 and most recently renewed via Resolution No. R-2013-110.

The Department of Public Utilities requested a proposal from Atkins North America to provide professional engineering services for the design, permitting, bidding and construction services for the water main replacement.

Administration recommends issuing an Authorization to Proceed with Atkins North America for a lump sum of \$587,453.

The proposed resolution provides funding from the Renewal, Replacement and Improvement Reserves.
