A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO STRYKER SALES CORP D/B/A STRYKER MEDICAL FOR A LIFEPAK 15 FOR AN AMOUNT UP TO \$61,817.13 IN ACCORDANCE WITH SECTION 38.41(C)(2) OF THE PROCUREMENT CODE. (SOLE SOURCE)

WHEREAS, the Department of Fire Rescue and Beach Safety ("Fire Department") desires to purchase a Lifepak 15 device to deliver services for the Mobile Integrated Healthcare Program; and

WHEREAS, the Fire Department has determined that the Lifepak 15 device from Stryker Sales Corp d/b/a Stryker Medical ("Stryker") is a sole source purchase due to Stryker being a proprietary company and the equipment manufacturer; and

WHEREAS, Notice to Sole Source Number NTSS-295-25 was posted electronically on OpenGov from March 5, 2025, through March 13, 2025, and received no inquiries; and

WHEREAS, the Acting Fire Chief and Chief Procurement Officer recommend that the City Commission authorize the issuance of a Purchase Order to Stryker for a Lifepak 15 device in an amount up to \$61,817.13; and

WHEREAS, this purchase with Stryker will cause the amount being paid to Stryker to exceed \$100,000.00 for Fiscal Year 2025, and therefore, City Commission approval is required for the payment of additional fees to Stryker; and

WHEREAS, Section 38.41(C)(2) of the City's Procurement Code exempts solesource goods, supplies, materials, equipment and services, such as unique, patented, or franchised goods, supplies, materials, equipment or services, from the competitive bid requirements if the Chief Procurement Officer determines after conducting a good faith review of available sources, that the particular supply or service is available from one source; and

WHEREAS, funding for this Purchase Order is available in account numbers 118.219802.52200.552320.001946.000.000 and 111.219801.52200.564530.000000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
