A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED AGREEMENT FOR TRAFFIC CONTROL BETWEEN OAKRIDGE PROPERTY OWNERS ASSOCIATION, INC. AND THE CITY OF HOLLYWOOD.

WHEREAS, the City of Hollywood recognizes that it has full power and jurisdiction to enforce all laws of the State, County and City, duly enacted, excluding those of traffic control and enforcement upon private property with limited exceptions; and

WHEREAS, the private community of Oakridge desires to specifically grant the City the power and authority to enforce traffic control within their respective boundaries and to grant an easement for ingress and egress for said purpose; and

WHEREAS, pursuant to Section 316.06(2)(b), Florida Statutes, a private property owner may contract with local government to exercise jurisdiction for traffic regulation and enforcement over private or limited access roads owned or maintained by the private party; and

WHEREAS, on April 29, 2015, the Board of Directors for Oakridge, at a duly noticed Board meeting, approved the attached agreement by a majority vote; and

WHEREAS, the private community of Oakridge has agreed to sufficiently indemnify the City in consideration for traffic control and enforcement within their respective community; and

WHEREAS, the attached agreement shall be for a five (5) year term and may be renewed for one (1) additional five (5) year period; and

WHEREAS, the Interim Chief of Police recommends that the City Commission approve and authorize the appropriate City Officials to execute the attached Agreement for Traffic Control between the Oakridge private community and the City of Hollywood;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

RESOLUTION: AGREEMENT FOR TRAFFIC CONTROL WITH OAKRIDGE PROPERTY OWNERS ASSOCIATION, INC.

<u>Section 1</u>: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached Agreement for Traffic Control between Oakridge Property Owners Association, Inc. and the City of Hollywood together with such non material changes as may subsequently be agreed to by the City Manager and approved as to form and legality by the City Attorney.
