The X2 Taser was the only Taser on the market that meet all the criteria standards.

Low Risk to transition current Tasers to the X2 Tasers. A risk analysis was considered in determining the impact/readiness of the Police Department should another Taser Brand be selected. Based on the following factors; All Sworn Members are already certified with the Taser product line—no learning curve, Members are already familiar with the Taser product line, We already have all the software and hardware for the Tasers—no additional software will have to be purchased, We currently have 4 certified Taser trainers—refresher training can be conducted in-house—any new product would require addition training and outside instructors.

Also Google Search Engine was used to see if there are any other vendors who makes and sells the X2 Taser—there are no others.

SUBJECT: Purchase of the X2 Taser

ISSUE:

Replacement of the current issued Conducted Electrical Weapon (CEW), the Taser X26 with the Taser X2.

EXPLANATION:

The Department's inventory of 250 Taser X26's are beginning to malfunction at a high rate and are no longer under warranty. Thirty of the X26's have recently sent to Taser International for repairs, however, Taser International has discontinued the X26 and will not guarantee any future repairs on this model.

The Training Unit recommends transitioning from the Taser X26 to the Taser X2. The Taser X2 is a "Smart" Taser with "smart cartridge" technology. The X2 has the shaped pulse technology with charge metering calibration. This means the Taser X2 will measure the output of each pulse, 20 pulses per second, and will adjust the amount of charge to increase the likelihood of neuro-muscular incapacitation (NMI). Additionally, the Taser X2 has enhanced data logs which record the following; when the incident occurred, a pulse by pulse accounting of the charge delivered (if there was a good connection or not), and how the CEW performed during the event. The X2 is equipped with an APPM auto shutdown battery which will give an audible alarm when the Taser's deployment length is at 3 seconds and will automatically shut down after 5 seconds.

In addition, the developments to the X2 will provide improved Officer Safety in the features outlined below:

 The X2 model has two cartridges ready for deployment and has dual lasers to show where both probes will make contact with an actively resisting subject.

- With the X2's dual cartridge capability, if one or both probes miss the subject on the first deployment, the Officer can immediately deploy the second cartridge without having to re-load.
- The dual cartridges allow the Officer to incapacitate two subjects simultaneously.
- The X2 has an ARC (Arc display/Re-energize/Cartridge advance) switch which can provide the Officer the ability to display a warning arc, which serves as an increased safety measure to de-escalate the situation without engaging in further violence or injury to the subject or fellow Officers.
- The ARC switch allows for drive stun capability without probe deployment.
- The ARC switch is used to toggle between both cartridges, preventing the
 accidental discharge of the second cartridge if the subject continues to
 actively resist and the Officer has to deliver a second burst.
- The blast doors for the X2 cartridge are durable and will not be discharged via static electricity.
- The Officer no longer needs to remove the cartridge prior to spark testing the Taser. This will eliminate the "bad" muscle memory of removing the cartridge prior to arming the Taser in a confrontation.

The added improvements to the X2 will provide enhanced safety to the Officer as well as the offender, improved data recording capabilities and greater transparency during the Departmental investigation resulting from a Taser deployment.

The cost associated for the purchase of 240 Taser X2 units, all required accessories, an additional four year warranty and Taser International discount for the destruction of existing units is included on the attached document.

RECOMMENDATION:

It is requested to utilize \$351,502.42 of LETF funds to purchase the above mentioned Conducted Electric Weapons.

(TASER) warranty provisions are applicable on all sales or transfers of TASER Law Enforcement Products, including conducted electrical weapons (CEWs), on-officer audio/video cameras and related accessories outside the U.S. and Canada. The term "Purchaser" means any purchaser, possessor, or user of the TASER products. BY USING THE TASER PRODUCT YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THE WARRANTY AS SET OUT BELOW.

Manufacturer's Limited Warranty²

TASER warrants that its Law Enforcement Hardware Products3 are free from defects in workmanship and materials for a period of ONE (1) YEAR from the date of receipt. CEW cartridges and Smart cartridges that are expended are deemed to have operated properly4. The TASER XREP CEW has a ONE (1) YEAR failure to fire manufacturer's limited warranty from the date of receipt when fired from an Approved Shotgun⁵. TASER-manufactured accessories⁶ are covered under a limited 90-DAY warranty from the date of receipt. Non-TASER manufactured accessories are covered under the manufacturer's warranty. In the event any country imposes a longer express warranty term than that described in this warranty document, then the country's term will take precedence.

If a valid warranty claim is received by TASER within the warranty period, TASER agrees to repair or replace the product which TASER determines in

its sole discretion to be defective under normal use, as defined in the product instructions. TASER's sole responsibility under this warranty is to either repair or replace with the same or like product, at TASER's option.

Optional Extended Hardware Warranty for AXON flex, AXON body, ETM, EVIDENCE.com Dock, TASER CAM HD and the X2, X26, X26P, and M26

The optional extended warranty, when available, may only be purchased at the point of sale product. The extended warranty runs from the date of receipt of the extended warranty through the balance of the 1-year limited warranty plus the term of the extended warranty measured after the expiration of the 1-year limited warranty. Purchaser may not buy more than one extended warranty for any one specific product. The extended warranty does not cover user-removable battery replacement, abuse, intentional or deliberate damage to the product, or force majeure during the extended warranty period.7 For customers who purchase an extended warranty, TASER warrants it will repair or replace the TASER product, which fails to function for any reason not excluded by this warranty, ONE (1) time during the extended warranty period with the same or like product, at TASER's option. When a product or part is exchanged, any replacement item becomes Purchaser's property and the replaced item becomes TASER's property. After the warranty period, TASER may, at its sole option, repair or replace a TASER product for a fee. A paid for out-of-warranty repair or replacement product comes with the manufacturer's limited warranty.
