A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A BLANKET PURCHASE AGREEMENT TO RAZORBACK LLC FOR GENERAL CONSTRUCTION & CONSTRUCTION MANAGEMENT AT RISK IN AN ANNUAL AMOUNT UP TO \$300,000.00 FROM JANUARY 21, 2026, THROUGH JULY 13, 2028, BASED UPON AGREEMENT NO: 41-25-14 IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE. (PIGGYBACK)

WHEREAS, the Department of Public Utilities ("Department") desires to retain an on-call service contract for the emergency repairs of vertical and horizontal assets at the Southern Regional Wastewater Treatment Plant ("SRWWTP") and the Water Treatment Plant ("WTP"); and

WHEREAS, the contractor will be responsible for large-scale repairs beyond the capacity of City staff, by rapidly responding to urgent incidents to minimize service interruptions, and ensure the continued reliable operation of the utility system; and

WHEREAS, the desired services were competitively bid by City of Zephyrhills through General Constructions & Construction Management at Risk RFP #2025-004 on June 10, 2025, and awarded to Razorback LLC ("Razorback") under Agreement No. 41-25-14; and

WHEREAS, the current term of the General Construction & Construction Management at Risk Agreement, No: 41-25-14 is from July 14, 2025, through July 13, 2028, with an option to renew the contract for two additional three-year terms; and

WHEREAS, Razorback has agreed to extend to the City the exact pricing under the terms and conditions outlined in Agreement No: 41-25-14; and

WHEREAS, the period of performance during which the desired General Construction & Construction Management at Risk will be acquired for the period from January 21, 2026, to July 13, 2028, for an annual amount up to \$300,000.00; and

WHEREAS, the departmental breakdown is as follows, \$125,000.00 is designated for the Water Treatment Plant, \$100,000.00 is designated for Wastewater Plant Operations, \$75,000.00 is designated for Wastewater Plant Maintenance; for the total sum of \$300,000.00; and

WHEREAS, Section 38.41(C)(5) of the Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of the Department of Public Utilities and Chief Procurement Officer recommend that the City Commission approve and authorize the issuance of a Blanket Purchase Agreement to Razorback LLC for General Constructions & Construction Management at Risk for the period from January 21, 2026, to July 14, 2028, in an annual amount up to \$300,000.00; and

WHEREAS, a portion of the funding for the Blanket Purchase Agreement is available in the FY 2026 Operating Budget in account numbers 442.400502.53600.546301.000000.000.000, 442.400601.53600.552240.000000.000.000 and 442.400602.53600.546350.000000.000.000 and will be budgeted in subsequent fiscal years' operating budgets subject to approval and adoption by the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of a Blanket Purchase Agreement to Razorback, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
