A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH PORT CONSOLIDATED, INC. FOR THE PURCHASE AND DELIVERY OF UNLEADED GASOLINE AND DIESEL FUEL IN AN ESTIMATED ANNUAL AMOUNT OF \$2,500,000.00 BASED UPON THE CITY OF POMPANO BEACH COOPERATIVE PURCHASE SERVICE CONTRACT NO. 1356 IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE (PIGGYBACK).

WHEREAS, the Fleet Management Division of the Department of Public Works desires to purchase unleaded gasoline and diesel fuel delivered to the Central Fueling Facility for City vehicles and equipment, and the purchase of red dye diesel fuel and recreational unleaded 90 octane for the Marina and resale to the general boating public; and

WHEREAS, the desired unleaded gasoline and diesel fuel were competitively bid by the City of Pompano Beach through Cooperative Purchase Request for Proposals Number E-03-22 ("RFP") on October 28, 2021, and awarded to Port Consolidated, Inc. ("Port Consolidated") under Service Contract No. 1356 for Unleaded Gasoline and Diesel Fuel; and

WHEREAS, the City participated, along with various other governmental entities, in the Cooperative Purchase RFP for Unleaded Gasoline and Diesel Fuel, issued by the City of Pompano Beach acting as the lead agency for the Southeast Florida Governmental Purchasing Cooperative; and

WHEREAS, on February 24, 2022, the City of Pompano Beach City Commission awarded Service Contract No. 1356 to Port Consolidated for an initial five-year contract term (March 15, 2022 to March 14, 2027), with the option to renew for an additional five-year term; and

WHEREAS, the period of performance during which the desired services will be acquired is from June 13, 2022 through March 14, 2027 in the annual amount of \$2,500,000.00; and

WHEREAS, Section 38.41(C)(5) of the Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference; and

WHEREAS, the Director of the Department of Public Works recommends that the City Commission approve and authorize the execution of the attached Blanket Purchase Agreement to Port Consolidated based upon Service Contract No. 1356 for Unleaded Gasoline and Diesel Fuel for an annual amount of \$2,500,000.00; and

WHEREAS, funding for the Blanket Purchase Agreement has been appropriated and exists in account numbers: 557.510101.51900.552110.000000.000.000 (Public Works), 442.400601.53600.552110.000000.000.000 and 442.400602.53600.552110.000000.000.000 (Waste Water Plant), 001.300301.57500.552110.000000.000.000 (Parks and Recreation), 001.215101.52200.552110.000000.000.000 (Fire) and 557.510101.51900.552610.000000.000.000 (Police), and will be requested in subsequent fiscal years.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the forgoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Blanket Purchase Agreement with Port Consolidated, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
