Dear Ms. Saini,

Please accept this letter as a commitment from the City of Hollywood (City) to continue providing maintenance for the medians and ramps located within the Hollywood Boulevard, Sheridan Street, and Stirling Road interchanges within the limits of the city and FDOT Limited Access Right of Way. This includes the existing landscaping and irrigation and the additional materials proposed with the Florida Department of Transportation (FDOT) Standalone Landscape project (FM 409354-4-52-01). The City will continue all maintenance activities within its limits of maintenance responsibility.

Although the specifics of each party's responsibilities for the project will be detailed in a forthcoming Maintenance Memorandum of Agreement (MMA), it is understood that FDOT will be responsible for funding the design and installation of the landscape and that the City will assume the cost of maintaining the landscape and irrigation, within the agreed upon maintenance limits and to the level specified, at the completion of the project's two-year establishment period. The City will have input into the design of the landscape within these limits.

The City agrees to the maintenance of the additional landscape and commits to working in good faith with FDOT and FDOT's consultants to complete and execute all amended agreements in a timely manner.
