A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT THE WALMART GRANT PROGRAM 2020 GRANT FUNDS FROM WALMART FOUNDATION TO DEFRAY THE COST OF POLICE DEPARTMENT PROGRAMING, SUCH AS HOLIDAY SHOP WITH A COP, IN AN AMOUNT NOT TO EXCEED \$2,500.00.

WHEREAS, the Police Department is requesting City Commission authorization to accept the Walmart Community Grant Program 2020 grant funds from Walmart Foundation; and

WHEREAS, Walmart Community Grant Program grant funds are available to law enforcement agencies interested in pursuing community programs in their respective communities; and

WHEREAS, the Police Department is seeking Walmart Community Grant Program 2020 grant funds to defray the cost of Police Department Programming, such as Holiday Shop with a Cop; and

WHEREAS, the acceptance of the grant funds does not require a contribution of matching funds and will incur no cost to the taxpayers of the City; and

WHEREAS, the Chief of Police recommends the appropriate City officials to accept the Walmart Community Grant Program 2020 grant funds from Walmart Foundation to defray the cost of Police Department Programming in an amount not to exceed \$2,500.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the appropriate City officials to accept the Walmart Community Grant Program 2020 grant funds in an amount not to exceed \$2,500.00.

Section 3: That the City Manager is authorized to accept the grant, provided that the City Manager shall have the discretion to refuse the grant in those circumstances

where he determines it is in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the grant.

Section 4: That upon Walmart Community Grant Program grant funds being awarded to the City, and the City Manager accepting the award, the appropriate City officials are authorized to execute all applicable grant documents and Agreements in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
