A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A CHANGE ORDER TO THE BLANKET PURCHASE AGREEMENT WITH JANICE M. RILEY, INC., D/B/A THE PAVING LADY, FOR ROADWAYS AND STREETS MAINTENANCE TO INCREASE THE CONTRACT AMOUNT FROM \$3,500,000.00 TO \$4,500,000.00.

WHEREAS, on January 17, 2024, the City Commission passed and adopted Resolution No. R-2024-028, approving a Blanket Purchase Agreement ("BPA") PA600836 in an amount up to \$3,500,000.00 with Janice M. Riley, Inc., d/b/a The Paving Lady ("TPL"), for Roadways and Streets Maintenance for the period from January 17, 2024 to January 16, 2027, with the option to renew for two additional one-year periods; and

WHEREAS, the City Commission recommended expediting re-striping the streets, roadways, and overall general road maintenance as the absence of visible stop bars and roadway divider lines are a major safety concern; and

WHEREAS, the change order will allow the Department of Public Works to accelerate completion of the project; and

WHEREAS, the Department of Public Works wishes to issue a change order to BPA PA600836 to increase the contract amount from \$3,500,000.00 to \$4,500,000.00; and

WHEREAS, Section 38.48 of the Procurement Code states that all change orders that the City Manager is not authorized to approve must be formally approved by the City Commission, which includes this desired change order; and

WHEREAS, the Director of the Department of Public Works recommends that the City Commission approve and authorize a change order to the Blanket Purchase Agreement with TPL to increase the contract amount from \$3,500,000.00 to \$4,500,000.00; and

WHEREAS, funding in the amount of \$1,000,000.00 will be made available in an account number to be determined subject to adoption of a companion budget amendment resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.
