A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE PURCHASE ORDERS TO STRYKER FOR LUCAS DEVICES AND LIFEPAK 15 UNITS IN AN AMOUNT OF \$528,596.25 IN ACCORDANCE WITH SECTION 38.41(C)(2) OF THE PROCUREMENT CODE (SOLE SOURCE).

WHEREAS, the Department of Fire Rescue and Beach Safety ("Department") desires to purchase Lucas Devices (\$99,837.33) and LIFEPAK 15 units (\$428,758.92) to deliver emergency medical services; and

WHEREAS, the Chief Procurement Officer determined that the Lucas Device and LIFEPAK 15 from Stryker is a sole source purchase due to Stryker being a proprietary company and the equipment manufacturer; and

WHEREAS, Notice to Sole Source Numbers NTSS-013-23 (Lucas Devices) and NTSS-014-23 (LIFE-PAK 15 units) were posted electronically on OpenGov from November 3, 2022 through November 10, 2022 and received no inquiries; and

WHEREAS, the Office of Procurement and Contract Compliance received no inquiries or comments on the Notice to Sole Source Numbers NTSS-013-23 (Lucas Devices) and NTSS-014-23 (LIFEPAK 15 units); and

WHEREAS, the Fire Chief and the Chief Procurement Officer recommend that the City Commission approve and authorize the issuance of the attached Purchase Orders to Stryker Medical for Lucas Devices in the amount of \$99,837.33 and LIFEPAK 15 units in the amount of \$428,758.92, for a total purchase amount of \$528,596.25; and

WHEREAS, Section 38.41(C)(2) of the City's Procurement Code exempts solesource goods, supplies, materials, equipment and services, such as unique, patented, or franchised goods, supplies, materials, equipment or services, from the competitive bid requirements if the Chief Procurement Officer determines after conducting a good faith review of available sources, that the particular supply or service is available from one source; and

WHEREAS, funding for the attached Purchase Orders is available in account numbers 335.219901.52200.564530.001607.000.000, 111.219802,52200.564530.001614.000.000, 334.219901.52200.564530.001614.000.000 and 334.219901.52200.564530.000104.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the issuance, by the appropriate City officials, of the attached Purchase Orders with Stryker, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
