SUBJECT: LETF Funding for Purchase of New Patrol Canine

ISSUE:

Request to utilize LETF -- Protracted funds to purchase new Police canine.

EXPLANATION:

Due to recent promotions and transfers, the Hollywood Police Department has a need to purchase a new canine partner for the newly assigned Canine Unit Sergeant. A canine has been identified by the Orchard Knoll Kennels, who has provided the City of Hollywood Police Department with quality police canines for over twenty years. The new Belgian Malinois canine is a titled dog which we anticipate will require minimal training before being FDLE certified and deployed into active service. The new canine team will be a force multiplier for Patrol functions, utilized to conduct building searches, area searches, tracks and apprehensions. Police canine teams have proven effective and efficient while locating and apprehending dangerous felony suspects, while providing enhanced officer safety. The new canine team will also be an effective addition to current CID operations targeting active burglary groups operating within the City of Hollywood.

The costs associated with the ongoing training and importation of Police canines continually increase, primarily due to a greater demand for Police canines. Significant public safety events and terrorism threats have taxed the market.

RECOMMENDATION:

Canine "Einer" will cost \$14,500.00. Purchase of a Police canine is a non-reoccurring expenditure and historically not a budgeted line item. This writer respectfully request the purchase be made utilizing LETF – Protracted funds.

ISSUE:

Justification for Best Interest Purchase of Police Canine.

EXPLANATION:

The Hollywood Police Department has historically purchased Police Canines from Mr. Ken Mathias (Orchard Knoll Kennels), who is a canine trainer/importer, located in North Carolina. For over twenty years, Orchard Knoll Kennels has provided the Department with quality canines who have successfully completed the rigorous 480 FDLE mandated Canine Training School and continued to serve the City for many years. In the rare event a canine has displayed any social, medical, and/or obedience concerns, Mr. Mathias has taken the canine back and immediately replaced it with an acceptable one. Other importers have contacted the Department throughout the years, however, none have offered the same level of quality, obedience, training, and social skills that Mr. Mathias' canines have demonstrated.

This purchase is operationally necessary to fill a vacant position created by the current Canine Unit Sergeant's promotion.

RECOMMENDATION:

It is recommended that the City purchase one new Police Canine without going through the bid process. The cost will be \$14,500.00 and funding is available in LETF account.
