A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CALLING FOR THE GENERAL ELECTION AND A SPECIAL ELECTION TO BE HELD ON NOVEMBER 8, 2022; AUTHORIZING AND DIRECTING THE CITY CLERK TO TAKE CERTAIN ACTIONS IN CONNECTION THEREWITH: AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN THE BROWARD AGREEMENT WITH COUNTY OF ELECTIONS REGARDING SUPERVISOR THE ELECTION.

WHEREAS, the City has a districted form of elections with a Mayor elected at large and six Commissioners elected from districts, as established by the City Charter; and

WHEREAS, the City will be having a general election to be held on November 8, 2022 (the "General Election"); and

WHEREAS, the terms of the City Commissioners from Districts 1, 3 and 5 expire in November 2022; and

WHEREAS, the District 6 City Commissioner Linda Sherwood has resigned her seat effective November 30, 2022; and

WHEREAS, the Broward County Supervisor of Elections has informed the City that the Special Election for the District 6 seat will have to be held in conjunction with the General Election on November 8, 2022; and

WHEREAS, the City will therefore seek a Special Election to be held on November 8, 2022, to fill the unexpired term for District 6 City Commissioner; and

WHEREAS, in order to conduct the elections, it is necessary to enter into the attached agreement with the Broward County Supervisor of Elections; and

WHEREAS, funding for the General Election and Special Election is available in account number 001.111001.51200.549930.000000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

- <u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
- Section 2: That the General Election shall be held on the first Tuesday after the first Monday in November, which is November 8, 2022, between the hours of 7:00 AM and 7:00 PM, at polling places designated by the Broward County Supervisor of Elections.
- Section 3: The City Commissioners from District 1, 3 and 5 will be elected to a four-year term.
- <u>Section 4</u>: That the Special Election for District 6 shall be held on the first Tuesday after the first Monday in November, which is November 8, 2022, between the hours of 7:00 AM and 7:00 PM, at polling places designated by the Broward County Supervisor of Elections.
- <u>Section 5</u>: That the candidate elected to the office of District 6 City Commissioner will fill the unexpired term until November 2024.
- Section 3: That the City Clerk is authorized and directed to place upon the ballot the names of all candidates properly qualifying for the General Election and Special Election.
- <u>Section 4</u>: That it approves and authorizes the execution by the appropriate City officials of the attached agreement with the Broward County Supervisor of Elections, together with such non-material changes as may be subsequently approved by the City Manager and approved as to form and legal sufficiency by the City Attorney.
