

RESOLUTION NO. R-2021-111

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH THE HIGHEST RANKED BIDDER, JUNIPER LANDSCAPING OF FLORIDA, LLC FOR ATHLETIC FIELD MAINTENANCE IN AN AMOUNT NOT TO EXCEED \$400,000.00.

WHEREAS, the City is seeking a well-qualified contractor with considerable experience in athletic field maintenance for the following facilities: Boggs Field – East; Boggs Field – West; Driftwood; Hollywood West; Rotary Park, and Washington Park; and

WHEREAS, on February 11, 2021, Bid #F-4664-21-RL–Athletic Field Maintenance was posted on BidSync and was viewed by 50 contractors; and

WHEREAS, on March 23, 2021, responses were received from the following four firms: BrightView Landscape Services, Inc.; DynaServe Florida LLC; Juniper Landscaping of Florida LLC, and YRY Homes LLC; and

WHEREAS, the City also received No Bids from the following two contractors: Calvin Giordano & Associates, Inc. and Court Surfaces; and

WHEREAS, on April 1-8, 2021, the Department of Parks, Recreation & Cultural Arts staff evaluated the sole proposal deemed responsive by Procurement Services from Juniper Landscaping of Florida, LLC (“Juniper”); and

WHEREAS, the evaluation of the proposal was based on the pricing shown in the bid tabulation; and

WHEREAS, the proposal was evaluated and staff confirmed the pricing from Juniper; and

WHEREAS, on April 8, 2021, staff notified Procurement Services to proceed with a Notice of Intent to Award for Juniper; and

WHEREAS, the Department of Parks, Recreation & Cultural Arts recommends that the City Commission authorize the appropriate City officials to execute an agreement with Juniper; and

WHEREAS, funding has been appropriated and exists in account number 001.300701.57200.5311700.000000.000.000, and will be requested in subsequent fiscal

years; and

WHEREAS, the contract term is for three years with an option to renew for two additional one year terms as mutually agreed upon by both parties.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:


Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
