A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO BIND THE RENEWAL POLICIES FOR PRIMARY AND EXCESS PROPERTY INSURANCE, FLOOD INSURANCE, PUBLIC OFFICIALS LIABILITY INSURANCE, BOILER AND MACHINERY/EQUIPMENT BREAKDOWN INSURANCE AND TO BIND A NEW FLOOD INSURANCE POLICY FOR ONE PROPERTY FOR WHICH NO FLOOD COVERAGE IS IN PLACE FOR A NOT TO EXCEED AMOUNT OF \$1,670,440.00 FOR WHICH QUOTES WERE SOLICITED BY ARTHUR J. GALLAGHER RISK MANAGEMENT SERVICES.

WHEREAS, the City desires to protect its assets through the purchase of various insurance products; and

WHEREAS, in accordance with the City's Purchasing Ordinance, Section 38.40(C)(9), purchases of insurance through the City's "Agent of Record" are exempt from the competitive bid and competitive proposal requirements; and

WHEREAS, on April 17, 2013, through RFP 4344-13-IS and Resolution R-2013-086, the City designated as its broker of record, Arthur J. Gallagher Risk Management Services; and

WHEREAS, Arthur J. Gallagher Risk Management Services solicited and/or obtained quotes from seventeen (17) carriers for the various layers of property insurance; and

WHEREAS, Arthur J. Gallagher Risk Management Services solicited and/or obtained quotes from three (3) carriers for public officials liability insurance; and

WHEREAS, Arthur J. Gallagher Risk Management Services solicited and/or obtained quotes from three (3) carriers for boiler and machinery/equipment breakdown insurance; and

WHEREAS, Arthur J. Gallagher Risk Management Services approach is to segregate the Utilities property from the remainder of the City's property; and

WHEREAS, based on the wind damage model estimates provided by the underwriters, the wind coverage of \$50 million for Utilities property and \$30 million for all other City property is adequate for a 250 year storm; and

WHEREAS, the City will maintain a 5% wind deductible with a minimum wind deductible of \$500,000.00 for the Utilities property and \$250,000.00 for all other City property; and

WHEREAS, in addition to renewing the property and flood insurance policies currently in place, the City is seeking to obtain flood coverage for one property with the same general terms and conditions as the flood renewal coverages; and

WHEREAS, the general terms and conditions for all coverages are the same as last year; and

WHEREAS, the total renewal costs for the aforementioned insurance policies are an estimated decrease of \$242,104.00 from the cost of the previous year; and

WHEREAS, funding has been identified and will be available in the Fiscal Year 2015 budget in the City's Self Insurance Fund (Fund 58).

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the binding, by the appropriate City Officials, of policies embodying the terms and conditions approved by the City Commission for the renewal policies for primary and excess property insurance, flood insurance, public officials liability, boiler and machinery/equipment breakdown insurance and for a new flood insurance policy for one property for which no flood coverage is in place for a not to exceed amount of \$1,670,440.00 in forms acceptable to the City Manager and approved as to form and legality by the City Attorney.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
