A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO RENEW A BLANKET PURCHASE AGREEMENT WITH SULPHURIC ACID TRADING COMPANY INC. FOR THE SECOND RENEWAL PERIOD IN AN ANNUAL AMOUNT UP TO \$504,000.00 FOR THE SUPPLY AND DELIVERY OF SULFURIC ACID IN ACCORDANCE WITH SECTION 38.49(C)(1) OF THE PROCUREMENT CODE (RENEWALS).

WHEREAS, on June 5, 2019, the City Commission passed and adopted Resolution No. R-2019-156, approving the execution of a Blanket Purchase Agreement (“BPA”) with Sulphuric Acid Trading Company Inc. (“SATCO”) for the supply and delivery of sulfuric acid in an estimated annual amount of \$430,000.00 for an initial three-year term from June 1, 2019 to May 31, 2022, with three additional one-year renewal periods; and

WHEREAS, on July 6, 2022, the City Commission passed and adopted Resolution No. R-2022-202 approving the execution of the first renewal period for BPA No. PA600113 from June 1, 2022 to May 31, 2023, in an amount up to \$504,000.00; and

WHEREAS, the Department of Public Utilities and SATCO desire to renew BPA No. PA600113 for the second renewal period from June 1, 2023 to May 31, 2024, in an amount up to \$504,000.00; and

WHEREAS, Section 38.49(C)(1) of the Procurement Code states that when a contract entered into by the City pursuant to City Commission approval provides for one or more renewals by affirmative action of the City and the estimated annual cost of a renewal exceeds \$250,000.00, only the City Commission is authorized to approve such renewals, which applies to this desired renewal; and

WHEREAS, the Director of the Department of Public Utilities and the Chief Procurement Officer recommend that the City Commission approve and authorize the second one-year renewal of BPA No. PA600113 with SATCO in an annual amount up to \$504,000.00; and

WHEREAS, funding for the renewal of the Blanket Purchase Agreement has been appropriated and exists in account number 442.400501.53600.552330.000000.000.000 and will be requested in subsequent fiscal years.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the second renewal of Blanket Purchase Agreement No. PA600113 with Sulphuric Acid Trading Company Inc., by the appropriate City officials, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
