A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO JAHNKE & SONS CONSTRUCTION, INC., D/B/A WHP TRAINING TOWERS, FOR NECESSARY REPAIRS AT THE FIRE TRAINING TOWER FOR AN AMOUNT UP TO \$121,270.00 IN ACCORDANCE WITH SECTION 38.41(C)(2) OF THE PROCUREMENT CODE. (SOLE SOURCE)

WHEREAS, the Department of Fire Rescue and Beach Safety ("Fire Department") desires to make necessary repairs to the Fire Training Tower; and

WHEREAS, the Fire Department and interim Chief Procurement Officer have determined that the necessary repairs from Jahnke & Sons Construction, Inc., d/b/a WHP Training Towers ("WHP Training Towers"), are a sole source purchase due to WHP Training Towers being a proprietary company and the materials manufacturer; and

WHEREAS, Notice to Sole Source Number NTSS-208-24 was posted electronically on OpenGov from May 29, 2024 through June 6, 2024, and received no inquiries; and

WHEREAS, the Fire Chief and the interim Chief Procurement Officer recommend that the City Commission authorize the issuance of a Purchase Order to WHP Training Towers for necessary repairs in the amount up to \$121,270.00; and

WHEREAS, Section 38.41(C)(2) of the City's Procurement Code exempts solesource goods, supplies, materials, equipment and services, such as unique, patented, or franchised goods, supplies, materials, equipment or services, from the competitive bid requirements if the Chief Procurement Officer determines after conducting a good faith review of available sources, that the particular supply or service is available from one source: and

WHEREAS, funding for this project was included in the amended FY 2024 Capital Improvement Plan and is available in account number 334.219901.52200.546301.001850.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it authorizes the issuance, by the appropriate City officials, of a Purchase Order to WHP Training Towers, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.
