A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO UTILIZE BLANKET PURCHASE AGREEMENT PA600617 WITH BRENNTAG MID-SOUTH, INC. FOR THE SUPPLY AND DELIVERY OF ONE-TON CYLINDERS OF LIQUID CHLORINE FOR A ONE YEAR PERIOD IN AN ANNUAL AMOUNT UP TO \$1,007,200.00.

WHEREAS, on December 7, 2022, the City Commission passed and adopted Resolution No. R-2022-366, approving a Blanket Purchase Agreement in an amount up to \$981,200.00 with Brenntag Mid-South, Inc. ("Brenntag") for the supply and delivery of one-ton cylinders of Liquid Chlorine for the first year of an initial two-year term from December 7, 2022 to December 31, 2023; and

WHEREAS, the Department of Public Utilities ("Department") desires to utilize the second year of the initial two-year term of Blanket Purchase Agreement ("BPA") PA600617 in an annual amount up to \$1,007,200.00 for the period from January 1, 2024 to December 31, 2024; and

WHEREAS, the Director of the Department recommends that the City Commission approve and authorize the second year of the initial two-year term of BPA PA600617 with Brenntag, in an annual amount up to \$1,007,200.00; and

WHEREAS, a portion of the funding for BPA is available in the FY 2024 Operating Budget in account number 442.400601.53600.552330.000000.000.000, and will be budgeted in subsequent fiscal years' operating budgets subject to approval and adoption by the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the use, by the appropriate City officials, of BPA PA600617 with Brenntag for the second year of the initial two-year term in an annual amount up to \$1,007,200.00, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.
